#### From The Desk of the Department Judge Advocate Larry Sheets

It is important to note that Posts are urged to update



their Constitution and By-Laws every three years. Even if you do not change anything, you should still go over them and mail them in to Department, so that we can attach a new cover letter stating that they were approved with a new date.

Should a Post decide to change something in their Constitution and By-Laws, the Post Commander should appoint a committee to review them, and recommend any changes that may need to be made.

Notify the Post membership in accordance with your Constitution and By-laws, in the time required, of the time and date which the recommended amendments will be voted on. Keep in mind that it requires a 2/3 majority vote to make any changes.

Once the above has been accomplished, mail a copy of your existing Constitution and By-Laws along with another copy which includes the changes approved by the membership to Department Headquarters. Any changes should be in Bold Type.

Once they reach Department, Rachel will scan them to me, at which time I will go over them. If there is a problem with them I will deal directly with the Post Commander or Judge Advocate.

When final approval is made, you will be sent a letter, along with the new amended Constitution and By-Laws along cover letters from The Department Commander and myself, with the date they were approved.

Please follow the above as it simplifies the process, and will allow us to get everything accomplished as soon as possible. Unless I am swamped, I try to return them back to you in 15 days.

#### **CENTENNIAL CELEBRATION**

The American Legion will hold a 15 month commemoration of 100 years of service to veterans, military personnel, families and communities starting at the National Convention in 2018, continuing throughout 2019, continuing through the National Convention in 2019 and culminating on Veterans Day 2019. The Department of Florida will form a Centennial Celebration Observance Committee to develop a plan for events at the Department level. PNC Clarence Hill will serve as chairman of the committee and each District should appoint one member to serve on the committee. When selecting a representative, District Commanders should consider someone interested in history and willing to serve through the celebration. The goal is to have a committee established and hold a meeting at the Department Convention. Anyone else desiring to be on the committee should volunteer by email to cehill316@aol.com.

Posts are also encouraged to form their own centennial committees and plan events around significant events in their history. Each Post can convey its legacy by sharing historical photos, videos and print material on the Legion's new Centennial Celebration web page: www.legion.org/centennial. Detailed instructions on how to create a Post history page is available on the web page, as are the types of information a Post should look to identify for their centennial. For more information on the National web page, email ledwards@legion.org. Department HQ has copies of the Centennial Celebration Workbook that gives step-by-step procedures on creating and posting your history, and the Legacy Vision which is an overall guide to the process. ## John Dollinger POW/MIA Chairman

The National Memorial Cemetery of the Pacific or Punchbowl is home to many World War II veterans graves. In addition there are over 800 unidentified remain from the Korean Conflict. These remains were placed there by a Military Review Board after they were determined to be unidentifiable. There was little technology to identify remains at the time.

In 2012, due to advances in technology, scientists from the Joint POW/MIA Accounting

Command (JPAC) determined that the possibility of identifying the remains now existed. The unknown remains were disinterred for analysis and possible identification.

One set of remains that were recently identified are Army Cpl. Joseph Howard who was originally from Philadelphia PA. To identify Howard's remains, scientists from JPAC used circumstantial evidence and forensic identification tools, such as dental comparison, which matched Howard's records. Cpl. Joseph Howard was buried in Jacksonville, Florida on January 9, 2014

Today, 7,896 Americans remain unaccounted for from the Korean War. Using modern technology, identifications continue to be made from remains that were previously turned over by North Korean officials or recovered from North Korea by American teams.

#### Stanley Gold National Legislative Chairman

I want to thank everyone for all the cards and well wishes after my wife died. It meant a great deal to me.

New update on H.R. 1726, introduced by our Florida member of the House Bill Posey. It is about honoring the 65<sup>th</sup> Infantry regiment, the only all Hispanic segregated unit in the U.S. Armed Forces. They played a prominent role in three U.S. wars. Of all the honors Congress can bestow, the awarding of a Congressional Gold Medal is the most distinguished. The latest count as of January 18<sup>th</sup> has 243 co-sponsors (minimum needed is 290) and the senate bill S.1174 has 28 co-sponsors (minimum needed is 67). All Florida members are on the co-sponsor list.

Below is a small example of what our Legislative Department in Washington D.C. does on every "Bill" that effects veterans. They attend these types of meetings all year.

#### Oversight and Investigation Subcommittee Examines Surgical Implants

At a January 15 congressional hearing, The American Legion testified on the Department of Veterans' Affairs (VA) tracking system for surgical implants. The Legion also addressed the VA;s practice of allowing vendors into its operating rooms, and the Veterans Health Administration's (VHA) habit of circumventing the Federal Supply Schedule.

The testimony was presented by Veterans Affairs and Rehabilitation (VA&R) assistant director for health care, Roscoe Butler. "There are several problems with VHA policies and implementation of implant medicine healthcare." Butler told the subcommittee. "Most of these problems could be fixed with clear written directions from (VA) Central Office, and better oversight and consequences to enforce compliance."

The testimony notes VA still has a problem tracking surgical implants, and until it is fixed veterans remain at risk. An audit made by VA's Office of the Inspector General two years ago identified expired surgical devices on VA supply shelves. The government Accountability Office (GAO) has also indicated that VA has an inaccurate tracking capability in recording the serial numbers of implant surgical devise.

"The grave concern to The American Legion is that, in addition to having expired products on the shelves, veterans potentially could be walking around today with expired surgical implants." Butler said.

The American Legion is urging Congress to require VA to implement an automated tracking system that:

Initially records the serial number of a surgical implant device when procured and placed into VA's inventory.

Records the expiration date and

Alerts VA staff when the product is near its expiration date.

The Legion wants VA to accelerate its timeline for implementing a new Prosthetic Inventory System that includes these components; it also wants VA to verify that no veterans currently have expired surgical implants.

The Legion remains concerned that VA does not have an official policy on the presence of vendors in its operating rooms (ORs). While having vendors in ORs to provide technical advice may be medically necessary, it needs to be made clear that veterans have consented to their presence, and have received full disclosure that strictly adheres to a clearly delineated VA policy. VA has admitted that they do not have a specific policy regarding vendors in ORs.

Update on Flag Amendment Bills

On May 22<sup>nd</sup> House Joint Resolution (H.J.Res.) 47 was introduced by Rep. Spencer Bachus (AL). This legislation is a proposed constitutional amendment to protect the American flag from physical desecration. Its text states simply: "The Congress shall have power to prohibit the physical desecration of the flag of the United States." The measure currently has 24 co-sponsors.

On June 13th, Sen. Orrin Hatch (UT) introduced Senate Joint Resolution (S.J. Res.) 17, a companion measure. This measure currently has 22 co-sponsors.

The task before us now is finding additional co-sponsors for these two measures. Please contact your representative and senators, and ask them to become co-sponsors of the flag amendment in their respective chambers. (Resolution 272-2012)

#### VA Offers \$600 Million in Funding to Support Services for Homeless Veteran Families

Grant Program One of Many VA Initiatives to End Veterans' Homelessness

WASHINGTON – The Department of Veterans Affairs (VA) has announced the availability of up to approximately \$600 million in grants for non-profit organizations and consumer cooperatives that serve very low-income Veteran families occupying permanent housing through the Supportive Services for Veteran Families (SSVF) program.

"Those who have served our Nation should never find themselves on the streets, living without hope," said Secretary of Veterans Affairs Eric K. Shinseki. "These grants play a critical role in addressing Veteran homelessness by assisting our vital partners at the local level in their efforts. We are making good progress towards our goal to end Veterans' homelessness, but we still have work to do."

The SSVF program is designed to assist very low-income Veteran families who are homeless or at imminent risk of becoming homeless. The program employs a housing first model, an approach which centers on providing homeless Veterans with permanent housing quickly and then providing VA health care, benefits and services as needed.

Required services include outreach, case management, assistance in obtaining VA benefits, and providing or coordinating efforts to obtain needed entitlements and other community services. Grantees secure a broad range of other services for participants, including legal assistance; credit counseling; housing counseling; assisting participants in understanding leases, securing utilities, and coordinating moving arrangements; providing representative payee services concerning rent and utilities when needed; and serving as an advocate for the Veteran when mediating with property owners on issues related to locating or retaining housing. Grantees also offer temporary financial assistance that provides short-term assistance with rent, moving expenses, security and utility deposits, child care, transportation, utility costs, and emergency expenses.

VA announced the availability of funds today through a Notice of Funding Availability (NOFA) via the Federal Register. VA is offering \$300 million in FY 2014 funds and \$300 million in FY 2015 funds, subject to available appropriations. VA will make award decisions based on a national competition.


In FY 2013, VA awarded approximately \$300 million in SSVF grants for operations beginning in FY 2014. VA is focusing up to \$300 million in surge funding on 76 high priority continuums of care in an unprecedented effort to end Veterans' homelessness in these communities. In FY 2013, funding from the SSVF program served over 39,000 Veterans and over 62,000 participants (i.e., Veterans and their family members).

In November, VA and the Department of Housing and Urban Development (HUD) announced the results of the 2013 Point-in-Time Estimates of Homelessness, which was prepared by HUD. The report estimated there were 57,849 homeless Veterans on a single night in January in the United States, an eight percent decline since 2012 and a 24 percent decline since 2010.

The SSVF program is authorized by 38 U.S.C. 2044. VA implements the program by regulations in 38 CFR part 62. More information about the program can be found at www.va.gov/homeless/ssvf.asp.
