

This award will also be presented at the Department Convention. New this year is "Runner Up" Department Sgt-at-Arms "BRAVO ZULU" Awards will also be given!

As Sgt-at-Arms you are an Officer of the post and on your Executive Board. You are also a vested member of your Post which means that you are responsible for the management of your Post as well as the appropriate documents being filed by the appropriate Post officers. You won't know if it is done unless you ask or if it is reported at one of the meetings. So at your next meeting please ask these questions:

- 1. Has the Post renewed its State of Florida Incorporation papers for 2013?
- 2. Has your Post filed its 2012 Form 990 with the IRS?
- 3. Always ask every month if your Post has filed its DR-15 Form (Florida State Sales Tax), Form 941 (Employer's QUARTERLY Federal Tax Return); Form 940 (Employer's Annual Federal Unemployment (FUTA) Tax Return); UCT-6 (Florida Department of Revenue Employer's Quarterly Report for Unemployment Tax); and any other forms that you may be required by your City, the State and Federal governments!

Take a walk through your Post and verify that ALL Licenses and Certificates are not expired or getting ready to expire. Be a fully involved Legionnaire with your Post and know what must be done. We have to make sure nothing t comes back and hurts the Post when it's too late. These all have deadlines! Keep up the Great work! "For God and Country"

Volunteers Needed For National Veterans Wheelchair Games

Quad Rugby is one of the 18 different competitive events and two exhibition events taking place during the 33rd National Veterans Wheelchair Games to be held in Tampa July 13 to 18.

Athlete registration is open and about 3,000 volunteers are needed for the 33rd National Veterans Wheelchair Games, the largest annual wheelchair sports event in the world. More than 500 Veterans from across the United States, Puerto Rico and Great Britain are expected to compete in the Games, taking place in Tampa July 13 to 18.

The Games are presented by the Paralyzed Veterans of America and the U.S. Department of Veterans Affairs. This year, they are co-sponsored by the James A. Haley Veterans' Hospital and the Florida Gulf Coast Chapter of Paralyzed Veterans of America. The Games are open to all U.S. military Veterans who use wheelchairs for sports competition due to spinal cord injuries, neurological conditions, amoutations or other mobility impairments.

Volunteers are needed to help support all event areas of the games including setting up equipment at venues where the competitions are held, serving meals, monitoring buses used to transport athletes to various locations, serving as "Fans in the Stands." (cheering the athletes on), and other duties.

"We're excited to see the National Veterans Wheelchair Games return to Florida and feel especially privileged we were chosen to host them here in Tampa Bay alongside our Paralyzed Veterans of America Gulf Coast partners, said Kathleen Fogarty, JAHVH hospital director.

"Adaptive sports provide a vital role in continuing a seriously injured Veterans' rehabilitation through formidable competition that's just plain fun. And Tampa is a world class sports venue to showcase the country's best wheelchair athletes for an entire week. To help us do that, we will need the help of thousands of volunteers," she said.

Eighteen different competitive events and two exhibition events will take place at the Tampa Convention Center, Tampa Bay Times Forum, Raymond James Stadium, Lake Seminole Park, Hillsborough Community College (Dale Mabry campus), Silver Dollar Shooters Club, Pin Chasers, Jefferson High School and the Clearwater Long Center.

April 15th Deadline for Athlete Registration

Veterans interested in competing may download the registration packet from the Games' website: www.wheelchairgames.va.gov or contact Lesli Culver at Lesli.Culver@va.gov. The deadline to complete and postmark their registration is April 15.

Many Opportunities for Volunteers of All Ages

Volunteers will be needed the entire week of the Games and can be as young as 14 to participate. They must be willing to commit to a minimum of a four hour shift on the days they volunteer. Besides the experience of participating in the Games, volunteers will also receive a commemorative T-shirt. High school students who volunteer can earn community service credit towards their college application.



Congressional Updates

Senate Committee Examines Possible Effects of Sequestration

As the clock ticks to March 1, calls to not allow sequestration to go forward are getting louder on Capitol Hill this week. On February 12 Legion staff attended a Senate Armed Services Committee oversight hearing that took testimony from Department of Defense (DOD) witnesses who related the damage such cuts would make to operations to DOD and the services for the rest of the fiscal year.

The witnesses who testified on the impacts of sequestration and/or a full-year continuing resolution on the Department of Defense were: Ashton B. Carter, Deputy Secretary of Defense; Robert F. Hale, Under Secretary of Defense (Comptroller); General Martin E. Dempsey, USA, Chairman, Joint Chiefs of Staff; General Raymond T. Odierno, USA, Chief of Staff of the Army; Admiral Mark E. Ferguson III, USN, Vice Chief of Naval Operations; General James F. Amos, USMC, Commandant of the Marine Corps; General Mark A. Welsh III, USAF, Chief of Staff of the Air Force; and General Frank J. Grass, NGB, Chief, National Guard Bureau.

Deputy Secretary Carter said the American Taxpayer Relief Act of 2012 changed the dates and size of sequestration. The first sequestration will begin on March 1; in addition, a second sequestration due to a breach in the discretionary spending caps for Fiscal Year (FY) 2013 is scheduled to be implemented on March 27 (coinciding with the end of the concurrent resolution (CR) funding for FY 2013). The combined effects of these two sequestrations will require the Department to cut roughly \$46 billion from the annualized level of funding provided on the FY 2013 CR, all in the last seven months of the fiscal year which ends September 30. Sequestration cuts would apply to all of the DOD budget, including the Overseas Contingency Operations portion, with only one significant exception. Exercising his statutory authority, the President indicated his intent to exempt all military personnel funding from sequestration. This means, as a result, other DOD budget accounts must be cut by larger amounts to offset this exemption. The estimate is the other accounts would be reduced by roughly eight percent by the March 1 sequestration order, and by nine percent if both March 1 and March 27 sequestration orders occur. (Note: The Office of Management and Budget would calculate the precise sequester percentage and provide it in the sequestration order.)

Chairman Dempsey said approximately one third of these cuts would come from force structure. The other two-thirds of the reductions would occur in the modernization, compensation, and readiness accounts. He went on to say there is no foreseeable "peace dividend" on our horizon. The security environment is increasingly competitive and dangerous. End strength caps in the FY 2013 National Defense Authorization Act restrict our ability to manage our force, and therefore inhibit our ability to reduce spending as quickly and as responsibly as in past draw downs. Unlike past downturns that followed periods of significant modernization, much of our equipment is older or aging. And, health care costs are approaching unsustainable levels. [Resolution #55-F-2012] Base Closings and Sequestration

On February 13 Army Chief of Staff General Ray Odierno said at a press conference that if sequestration is allowed to go into effect, the military will have to be allowed to close bases. General Odierno said the Army would be forced to become so much smaller that it would be "inefficient" not to close bases. The base closure process would be paid for by the money not being spent on additional forces. Last year, the Pentagon proposed two rounds of base closures to save money in the future. Congress refused this request. However at the press conference, Odierno observed that, with the level of spending reductions required by the combination of the sequester and the continuing resolution (which holds spending at Fiscal Year 2012 levels), Congress would be forced to allow the closures. [Resolution #55-F-2012]

House Armed Services Committee Hearing: Sequestration & Budget issues

The committee met February 13 to discuss the impending implementation of the sequestration cuts, as well as the impact of operating under the continuing resolution (CR), which sets funding levels at Fiscal Year 2012 levels. Essentially this hearing mirrored the Senate Armed Services Committee hearing held earlier this week. The takeaway from this hearing is that the Committee leadership is opposed to any further reduction of Department of Defense (DOD) spending regardless of any other plans that Congress may propose.

bers of Congress to continue the work of The American Legion.

Several weeks ago, Legislative Division staff members delivered packets to the offices of newly-elected members of Congress. These packets contained a personalized welcome letter, a drop sheet of our organization's legislative priorities, a pamphlet outlining the Legislative Division's Guiding Resolutions, and a DVD. These packets were hand-delivered in order that the Legislative staff could introduce themselves, and begin to develop working relationships with the new congressional staff members. In addition, a packet containing the drop sheet and Legislative Point Papers was sent to each Department; these will soon be posted on the Legion website (www.legion.org).

The Legislative Division will be in charge of the "Commander's Call" on Tuesday morning February 26. The agenda is still being developed, and prospective speakers are being considered. Legislative Commission Chairman Ken Governor (NY) is coming to Washington in two weeks to work with staff to prepare the agenda.

American Legion Legislative Council

The Legislative Division continues the task of re-building the membership of the National Legislative Council for the 113th Congress. Council recommendation forms were emailed to Department leadership in December, asking for nominations for new congressional members. Completed forms were due in the Legislative Division offices in Washington, DC by January 18. To date, 37 Departments have returned their Council nomination forms.

The importance of the Legislative Council cannot be overstated. It is an especially important voice for The American Legion family, and the way in which members of Congress can be quickly contacted when legislative action is needed. Departments are urged to complete their nomination forms and return them to the Legislative Division offices as soon as possible. Update on Flag Amendment Bill

On January 18, House Joint Resolution (H.J. Res.) 19 was introduced by Representative Jo Ann Emerson (MO). This legislation is a proposed constitutional amendment to protect the American flag from physical desecration. Its text states simply: "The Congress shall have power to prohibit the physical desecration of the flag of the United States."

The next task is finding cosponsors for this legislation. Please contact the offices of your representative and senators, and ask them to become cosponsors of the flag amendment in their respective chambers. [Res. 272-2012]

We encourage Departments and Posts to give this information the widest dissemination, as we will do in your national publications. All submissions must be received no later than April 19, 2013, in order to be considered.

The Internal Affairs Commission will be the final reviewer of submissions, and will draft a resolution recommending a permanent tagline. The decision of the National Executive Committee is final.

If your tagline is the one recommended to the NEC, and adopted exactly as submitted, you will receive a \$500 check, and a Certificate of Appreciation plaque signed by the National Commander in recognition of your winning entry. The winning entry will be posted on www.Legion.org after the NEC meets in mid-May 2013. In the event of duplicate winning entries, the earliest received will be declared the winner.

Did You Know... Nearly 10% of the 1.7 million service members to deploy in support of OIF/OEF call Florida home. Florida has the 2nd largest per capita veteran population in the nation.
