At the National Executive Committee meeting in Indianapolis, IN, this past October, they passed two Resolutions pertaining to expand the possible membership eligibility dates into The American Legion.

Resolution 1 was six pages and Resolution 2 was four pages long. Instead of posting those Resolutions here in the Legion Link, I thought I would share my response to Martin W. Roewer, who had some concerns about our eligibility dates.

Membership eligibility in The American Legion is determined by the Congress of the United States of America through the establishment of specific dates of declared hostilities in which U. S. military personnel are activated for service.

The American Legion was created by Act of Congress under Public Law No. 47, 66th Congress approved on September 16, 1919, as a war-time period organization under declared hostilities dates declared by Congress. Congress has declared the following dates to fall under the declared hostilities which would make U.S. military personnel eligible to join The American Legion:

- **WWI**  
April 6, 1917 to November 11, 1918
- **WW II**  
December 7, 1941 to December 31, 1946
- **Korea**  
June 25, 1950 to January 31, 1955
- **Vietnam**  
February 28, 1961 to May 7, 1975
- **Lebanon/Grenada**  
August 24, 1982 to July 31, 1984
- **Panama**  
December 20, 1989 to January 31, 1990
- **Gulf War/War on Terrorism**  
August 2, 1990 – till cessation of hostilities

There are presently 12 combat operations since December 7, 1941, that are unrecognized by the U.S. government which occurred at the direction of the then current President of the United States, with full knowledge and consent of the then current U.S. Congress.

On October 17, 2018, at your National Executive Committee meeting in Indianapolis, IN, Resolution 1, Titled: Unrecognized Armed Hostilities Recognition was passed and approved to submit to the U.S. Congress for approval. If these dates are approved by Congress then it could lead to the eligible dates of December 7, 1941, through the cessation of armed hostilities at an as-of-yet undetermined future date.

Presently, our National staff in Washington D.C. is pursuing this Resolution and asking Congressmen and Senators to submit a Bill pertaining to this Resolution.

**A Word on Legion Caps**

First, I would like to thank the Department Assistant Sgt-at Arms for the outstanding and professional job they did at the Department Fall Conference in November. Great job by all.

I have been tasked to update the Sergeant-At-Arms duties and responsibilities manual this year. This is

where you can help: please look it over and give your input on what you think can be changed or added. It can be found on the Department website <https://www.floridalegion.org/resources/legion-post-documents/post-program-manuals/>.

In chapter 2, The Wearing of the American Legion Cap, Uniform and Regalia, Paragraph 8, female members of The American Legion should wear their caps in the manner prescribed for female personnel of the armed services. Paragraph 11a, the left side (emblem side) of any American Legion cap cannot contain other than the official American Legion emblem and lettering

as set forth previously in this Resolution for Post, County, District, Department or National caps. When placing your Legion cap down on a flat surface like a table, it shall be placed with the Legion emblem facing up as a sign of respect as the left side (emblem side) is considered "HALLOWED GROUNDS" and should be given proper respect.

As the holidays are approaching, get with your Post Commander and/or Adjutant and reach out to your older members to see how they are doing. It can get lonely during this time of year. Invite them to your Post or visit them for a short while.

### Western Area Update

First I want thank everyone for their thoughts and prayers while I was recovering from my heart attack. It was very difficult knowing that my Area was in distress

and there was nothing I could do for it. Fortunately, I have recovered to almost 100%, and while I was in the hospital, Jim Brennan, 2nd District Commander, and John Edens, 1st District Commander, led the way in their Districts. Of course, our Disaster Preparedness team of Steve Shuga, Bill Hoppner, and Chaplain Barry Roberts took charge of relief efforts and kept communication flowing.

For those that do not know, Post 375 in Southport was a total loss and will have to be rebuilt. Post 392 in Panama City has some roof damage and some trees that needed to be cleared. Post 66 on the Bay County Fairgrounds has roof damage to the Post home, but more severe damage to the fairgrounds itself. Post 402 in Panama City Beach is okay, and Post 356 in Lynn Haven has some damage to part of the Post home around the meeting room and kitchen and some outer building damage. In

District 2, Post 241 in Sneads suffered some outer building damage. Post 272 in Blountstown suffered some roof damage and damage to the A/C unit and fencing. Port St Joe Post 116 had some minor building damage, but the building is owned by VFW. There have been issues with our relief efforts for the area. The governmental agencies did not desire our support, so the focus switched to providing supplies to Post 402, Post 392, and Post 100 so that the Legionnaires could get them where they needed to be. Relief supplies are still coming in from up north and Post 392 still has supplies that are ready to be picked up by whoever needs them. If you have items to send, contact Steve Shuga or Bill Hoppner for instructions on what is needed and where to take them.

I drove through Panama City and saw the devastation. I can only imagine what it was like on the roads and back in areas that had not been cleared. It will be many months before things can be close to getting back to normal. The Department of Florida website has the forms needed for assistance from the National Emergency Fund, Dept of Florida Hurricane Relief, VetRelief, and the Auxiliary Emergency Relief Fund. <https://www.floridalegion.org/hurricane-relief/>.

The Fall Conference is behind us and I would like to thank everyone for the large turnout for training. Several questions were brought up and I am waiting on replies from National on the issues discussed.

Links to my Power Point presentations have been placed on the Department website for everyone to use. As we continue with training and recruitment, the ability to let people know who we are and what we do is important. A great way to keep up-to-date is the American Legion Basic Training (<https://www.legion.org/alej>), a free self-paced online course.

As we reach for our December and January goals, we need to work with our membership teams early on to have revitalizations/membership drives. Using the tools in MyLegion.org we can find

those members both in our Post and the DMS Post 400 who have not renewed. Many times, a simple phone call or email letting them know that you want them at your Post will suffice. Letters inviting them to the Post are available on MyLegion. The letter is ready to go once you check the blocks and put in your Commander's name. The best tool to get people to the Post is an appointment with a Service Officer. Let them know that membership is not required, our service officers are there to help any veteran. Once they stop by, let them know what our Family has for their family. Young veterans and their families have tight budgets but still want to go out and do things together. Support the local youth programs that your potential members enjoy, i.e. Little League, Youth Soccer, Scouting, Sea Cadets, and Police or Fire Explorer programs.

Let the community know some things American Legion Posts did "for God and Country" last year.

1. Donated more than 3.9 million hours of service to communities.

2. Post Service Officers handled 170,000 cases of veterans seeking benefits and just compensation from the Department of Veterans Affairs.
3. Devoted over 765,000 hours of volunteer service to Department of Veterans Affairs hospitals.

National Commander Reistad created a couple of incentives that will reward departments and posts for their hard work. Here is a quick snapshot of those new incentives:

- Departments that hit 100% of their 2019 membership goal by the Armed Forces target date on May 8th will receive \$2,500.
- Departments that hit 105% of their 2019 membership goal by the delegate strength date will receive \$5,000.
- If a department does not hit 100% by the Armed Forces target date they are not excluded from being able to receive the \$5,000 for hitting 105%.
- **Post can earn \$5 for bringing back expired members from 2014, 2015 and 2016. (STARTS DECEMBER 6, 2018)**
- This will run until May 8th, 2019.
- **Brand new members do not count.**
- Renewing members into the headquarters post does not count.

- These expired members have to renew at a traditional post. It does not have to be at their previous post.
- These lists will include expired DMS members as well.
- These members will need to be transferred into a local post and then renewed for the post to receive credit.
- Keep in mind their membership ID will need to be used for tracking purposes and to receive credit.
- These lists can be downloaded through myLegion.
- Checks will be presented during the Spring National Executive Committee Meeting in Indianapolis.

This is very exciting news for all of the Posts in Florida and throughout The American Legion. One other topic we at Department wanted to clarify to Post Leadership is how payments/credits are being processed under the new electronic renewal system. As you know, when you process the transmittal at the Post level (electronic submission), you are only required to pay the per capita fees. Meaning you retain the Post's portion of the dues. However, each time a member renews online as an individual, they submit payment for the full dues amount to National which means the Post will not

receive their funds for a minimum or thirty (30) days.

Recently, several Posts have contacted Department requesting the release of credit funds because they are now processing online transmittals and no longer utilize Department credits. After the individual Legionnaire renews online, Department runs a weekly report that reflects these payments. This report also accounts for your membership numbers/percentages. Department then enters the payments into the system, which generates a credit to the Post; however, National only processes actual payments back to Department on a monthly basis. This means that even though you may see a credit at Department, those funds have not actually been sent to Department as of the day the credit is posted. In fact, **it takes a minimum of thirty (30) days** for National to write the check back to Department.

At the Post level, Department is asking that each of you realize that when members renew online, **it will be a minimum of thirty (30) days** before Department receives that payment from National. Please send your requests in writing and we will process the payments in a timely manner once those funds have been received from National.

Your post will receive five dollars for every expired 2014, 2015 or 2016 member that renews at your post for 2019. After this incentive ends on May 8<sup>th</sup>, a check will be disbursed to your department and they will send it to each post individually. As you can see, this is a great opportunity to earn some money for your programs while growing membership in your post and department. It is truly a win-win situation for your post and The American Legion.

The expired members can be found by signing into myLegion and choosing "Reports/Labels" on the left-menu.

1. Open (double-click) the "Post Reports" folder.
2. Open the "Revitalization" folder.
3. There you will find three reports where you can select expired members for letters, labels and rosters ("Unrenewed\_Letters", "Unrenewed\_Labels", Unrenewed\_Roster")

If your post does not have access to myLegion, go to [www.mylegion.org](http://www.mylegion.org) and click on "Authorization Form" at the bottom of the page and complete the registration process. If you need assistance you can call 1.800.433.3318 or send an email to [mylegion@legion.org](mailto:mylegion@legion.org).

Once you and your membership team have contacted expired members and are ready to renew them back into your post, there are a few things to keep in mind. To receive credit for renewing a 2014, 2015 or 2016 Legionnaire, they must renew in your post and you have to use their current membership ID number. The ID number will be on the expired listing downloaded through myLegion or provided by your department. If the expired Legionnaire was not a member of your post, please transfer them into your post and then process their dues payment. I encourage you to not only go after past post members, but also DMS and headquarters post members.

Again, thank you for everything that you do for The American Legion. Let's proudly "celebrate our legacy" as we work to reach 100% in membership during our 100<sup>th</sup> anniversary. Thank you for being a member of Team 100.

With hurricane season still upon us we should really consider doing blood drives to assist in the needs of those who have been hit hard by the weather. Each

day, 15,000 donors are required to meet the ongoing need for blood and components.

During Fall Conference I had the pleasure of introducing myself to the Big Red Bus Phlebotomy Technician that was at the hotel on Thursday and we spoke about the members who were stationed in the European Area during the early 1980’s. She indicated that should you want to give blood,

please go and be questioned about when and where you were stationed as some may be able to give blood while others may not. It will have to be decided by the Phlebotomy Technician (Vampires) on duty.

On November the 10th my significant other (7th District Vice Commander) and I attended the Veterans Day Program and Blood Drive at Post 72, Mulberry, and after the service was over, I noted that there were several people lined up to give blood. That was a good feeling! Post Commander and 7th District Sgt-at-Arms Rick provided a nice meal for those who attended.

When considering a drive, the assets are: Community Service, Improved Public Relations, and Membership Growth. You could increase your membership by holding a drive.

There is a program to fit every Post.

**The Group Donor Plan:** this system calls for the development of a file of Legionnaires, Auxiliary members, and others who are willing and able to donate blood on a periodic basis.

**The Walking Blood Bank:** consists of registration and blood typing of eligible donors. In the event of an emergency the Blood Donor Chair need only call those with the needed blood type.

Blood donors may receive an American Legion Blood Donor pins and/or a Blood Donor Certificate. Awards for Posts with the best Blood Donor Program are in the Blood Donor Guide.

**Hurricane Aid**

I hope that all our fellow Legionnaires and family are safe following the aftermath of Hurricane Michael. We want you to be aware of The American Legion programs that are available to assist you during this time of recovery.

The American Legion's National Emergency Fund (NEF) provides immediate financial assistance to Legion Family members and Posts affected by Hurricane Michael. The fund provides up to \$3,000 for qualified members and up to \$10,000 for Posts.

NEF grants do not cover costs of items which should be covered by insurance. It is strictly for assisting Legionnaires with emergency travel, lodging and meals while under mandatory evacuation from their homes. These are considered emergency, out of pocket, living expenses.

**In order to qualify for an NEF grant, an applicant must:**

- Have been displaced from his or her primary residence due to a declared natural disaster.
- Must have sustained damage to their primary residence as a result of the declared natural disaster.
- Provide copies of receipts of items required to meet immediate needs, such as temporary housing, food, water, clothing, diapers, etc.
- Provide evidence of damage sustained to their residence.
- Membership must be active at time of disaster and the time of application.
- Post grants must derive from a declared natural disaster and substantiating documentation must provide that The American Legion Post will cease to perform the duties and activities in the community due to losses sustained.

While the NEF provides immediate assistance to Legion and SAL members, with qualified minor children of Legion-eligible veterans may receive assistance through the Legion's Temporary Financial

Assistance (TFA) program.

The TFA grants do not cover costs of items which should be covered by insurance. It is strictly for temporary food, shelter, utilities, and clothing.

Payout from the funds are currently capped at \$2,500 per veteran with minor children (17 years or younger) living at home. Legion membership is not required.

In addition, Department of Florida is also taking applications for the Department's Hurricane Relief Fund. This fund is similar to NEF; however, there is no need to have sustained damage to be eligible for funding. Also, the Department fund will support any veteran regardless of membership status. Legionnaires will have first consideration and the program will be active until funds are depleted.

I hope everyone had a wonderful Thanksgiving. As citizens of the United States, we have so much to be thankful for, especially those of us that served this nation in the U. S. military.

Without our service to uphold and preserve the U. S. Constitution and defend our way of life, who knows where we would be? I am sure we would not enjoy the freedom to call out our leaders when warranted, we would not enjoy the freedom to move about without restrictions, we would not enjoy the sanctity of owning and defending our own home, nor the opportunity to serve our fellow veterans in an organization known as The American Legion.

Do you know approximately 511,000

foreign-born immigrants share those same thoughts and enjoy the same freedoms here in the United States? They came here legally from another country, adopted the United States, raised their right hand to uphold and defend this nation, and made the same sacrifices as a domestic-born soldier, sailor, marine or airman.

Who are these eligible immigrants for service in the U. S. military?

They are naturalized citizens, lawful foreign-born permanent residents, certain nationals of three countries in free association with the United States—the Marshall Islands, the Federated States of Micronesia, and Palau. In addition, Congress can approve eligibility for foreign-born if a specific military service branch Secretary determines a need in the enlisted ranks is vital to the national interest.

Such a program was launched in 2009—Military Accessions Vital to the National Interest (MAVNI). In last month’s article, I stated that the promises made to these foreign-born enlisted personnel by the U. S. Army were being withdrawn and many soldiers discharged. Once discharged, their future is unclear and they may be subjected to deportation proceedings.

Most foreign-born who served in the U. S. military had an exceptional service period, many endured combat, performed without disciplinary incident, received an honorable discharge, and

tried to assimilate into civilian life. Unfortunately, they experience the same post-war mental health issues as their domestic-born counterparts. Issues such as PTSD and other mental and medical setbacks may lead to criminal activity. The chances of the foreign-born finding him or herself in the immigration court system is likely.

This is where life becomes different for them. They still have certain basic rights under the U. S. Constitution. The 14th Amendment guarantees due process and equal protection to all people in the United States—citizens and non-citizens alike. They are guaranteed to have their case heard. The immigration court system is civil rather than criminal. They have the right to retain counsel; however, they will not be provided counsel free if they cannot afford one. In 2016 data, only about 37 percent were able to secure counsel for their deportation process.

As fellow veterans, we owe it to them; especially those that served in a war zone and experienced the ravages of combat; to help. They stood up and wanted to serve their adoptive country. They paid the price as we

say. It is up to us to identify them not for deportation proceedings, but, for legal representation to determine their status and perhaps become a productive U. S. citizen. These veterans are not illegals who entered the country “under darkness of night.” These individuals were here legally and answered the call to serve and for whatever reason fell between the cracks since departing the military.

California and Florida are the states with the highest number of foreign-born veterans. I am asking the District Commanders, Area Commanders, and Zone Commanders as you travel, speak out about our fellow veterans who need our help to insure they get what was promised to them on entry into the U. S. military. Ask our Legionnaires in Posts in all corners of Florida to seek out our fellow veterans and get them the legal help necessary to assist them in their quest to become a U. Only a limited number of people from around the country can attend the National College, usually only one person from each Department. In our Department there is an FALC Committee which I chair, that designs classes for FALC following National's recommended subjects and

One of the main subjects covered in both National and Florida Legion College is the writing of Resolutions. By the way, he writes excellent articles for the Legion Link on the subject every month - I hope you read them.

If you attended the recent Fall Conference you heard discussion on National Resolutions 1 and 2 from the National Executive Committee's October 2018 meeting. This would open the membership door for veterans

**The Importance of Resolutions**

Resolutions are vital to the Legion's mission and is serious business. Without the resolution process, the Legion would have no guidance in developing programs, allocating funds to help veterans, or targeting Congress concerning issues that affect you, me, our families, and the rest of this great country.

Resolutions tell those in leadership roles what the members want. As adopted by your membership, a resolution represents a formal expression of the official opinion of your Post, District, Area, Department, or the National organization. When approved by the local membership, resolutions could proceed to the next step—either District, Area, or the Department level. At the Department level, resolutions are dealt with at a Department Executive Committee (DEC) Meeting or a Department Convention.

With formal authorization at the Department level, the resolution may be sent to National Headquarters where it

is registered for either the Resolutions Subcommittee for the National Executive Committee (NEC) or the Resolutions Assignment Committee of the National Convention. The resolutions are then forwarded by the National Adjutant to the appropriate national-level commission or committee for study. Finally, either the National Executive Committee or the National Convention delegates vote upon the recommended action.

Upon adoption at the national level by either the NEC or the National Convention, the resolution becomes the position of The American Legion.

Just like running a good Post, a Scout unit requires good adult volunteer leaders to make its mission a success. However, the requirements and characteristics of a Scout leader are much more stringent. This difference comes mostly because of the involvement with children.

Most often, leaders for Scout units come from the parents of the youth involved. Sometimes they come from Legion family members who were Scouts themselves as youth. Occasionally, they come from outside both those worlds. Regardless of where the leaders are found, the Post alone is responsible for the vetting and selection

of leaders for its Scout units.

When a leader prospect is identified and fills out the BSA registration form, it starts an investigative process of the individual. BSA will perform a credit check of the individual, an FBI criminal background investigation, a name match against several lists of prohibited persons, a driving record check, and other safeguards to protect the youth in its programs. But those checks will not tell the Post if it has selected good leaders.

Each year in the Fall Scout units start back up and recruit new members, both youth and adult. Not just anybody who wants to be an adult leader should be. Your Scout unit's Committee Chair may recommend adults for Scouting positions, but the Post Charter Organization Rep (COR) is the only individual who decides whether or not to accept them. It is the COR's signature on the registration application that seals the deal. The Post's

COR must be involved with all the adult selections.

Don't be trapped in the notion that it is better to have someone than no one. It's not. Each applicant for adult leadership should go through at least one personal interview with the COR before they are accepted. You may want to have them additionally interviewed by the Committee Chair as well. Here are some considerations for the interviews:

- Does the applicant have a positive attitude about their role or are they just caving in to pressure to help out?
- Does the applicant present as a role model in appearance and demeanor for the youth?
- Did the applicant complete mandatory BSA Youth Protection

Training beforehand?

- Did the applicant complete mandatory BSA Position Specific Training beforehand?
- Does the applicant have sufficient time in their personal schedule to perform the job?

- Does the applicant refrain from using alcohol, tobacco, and drugs in their personal life? (All are prohibited everywhere, all the time in Scouting.)
- Does the applicant refrain from using coarse, vulgar, and discriminatory language? (Never tolerated.)
- Does the applicant have any Scouting background?

Your Scout unit is a reflection of your Post and its leaders are a reflection of you. Be sure to take time and care in selecting them. The best question to always ask your self is this: Would I trust this person to take my children or grandchildren on a camping trip out in the woods?

First, I would like to thank those who attended the Fall Conference for your attendance and all of you for your dedication and hard work on behalf of the American Legion promoting The American Legion Riders. We have a lot to be proud of.

I've heard a lot of different conversations/ rumors concerning the ALR Department's plans. I thought it prudent to clarify numerous discussions and put the plans and dates in writing. To be clear, the planning was done based on the survey that was completed last year, YES, we listened to your comments.

There will be three ALR Department Rides a year,

- "Merry go Round for Children & Youth",
- "Round Robin for Project Vet Relief" and
- a group ride involving all the riders who want to participate. (Last year was an exception, as we tried a Unity Ride which involved 5 States. I did receive several comments from riders that felt left out and disenfranchised) about forgetting that we are a Florida Riders group and a lot of individuals could not afford that type of a ride.

**The Ride plan;** first and foremost, we are going to try and put together the most affordable ride (so we can maximize attendance) for all to enjoy. We do not need to stay at The Hampton Inn for \$100 plus a night, and we are going to try to stay at accommodations where we can keep the rate in the \$60-\$70 range & maintain a safe environment. This can be done. Starting February 15th all dollars donated to the "Round Robin" event will count toward the trophy dash in April. How you do that is entirely up to your post or district. As always, dollars collected will go to Project Vet Relief. It's for the "Cause not the applause"

The dates of the Ride will either be the first or second full week in April. This is driven by the availability of a very popular band that has offered to support The American Legion. The ride will go through all of the districts picking up donations along the way. The district will pick the location to try to centralize the ride, but it also must fit the in-state loop. (because of the hurricane we may not go through 1st & 2nd Districts – time will tell! )

The districts are currently picking the stops, once they are collected, a detailed turn by turn route will be constructed and a pre run will be performed to check the route and confirm the stops. The plan is to have this completed this month. We have several riders that have expressed interest in participating in the planning and the pre-runs.

We will be consulting the Automobile Clubs of America (AAA) on both the route and the hotels. They will also be able to quote all of the hotels at AAA rates, much lower than we could get! This

is all at not cost and a benefit of being a member !

One of the advantages of doing both of these Department activities in the same month, is that it frees up the riders to support the local events at their posts and districts which is a big part of our mission statement. This was also brought up in the survey to try to minimize department activities because of the "out of pocket costs" and time involved.

The Summit; February 7th to 10th (Hotel 6-10 February) at the International Palms Resort and Conference Center in Cocoa Beach. We changed the dates so that the American Legion Riders can support the 100th Anniversary Birthday Celebration – "Vets Invade the Canyon" at The Rock Crusher Canyon Pavilion in Crystal River from January 18th to 19th, hope to see you all there. I want to thank everyone for their help on the Summit planning. We have 17 instructors lined up, one left to fill, Hotel registration is open, shirts and coins designed and going live to our website in a couple of weeks, so we are all set.

I hope that clears up any confusion, if not please give me a call. Please share this with all of your District and Post Rider Chairpersons.

Once again, Thank You for what you do and I am proud to be the Chairman of such a great group.






