

I hope this finds everyone safe and in place. April has been a very busy month for the Department and staff trying to do the right thing for the Legion family. I have been in contact weekly with the Florida Legion

Family leadership during these trying times that we have been facing. A lot of great information has been discussed and accomplished as a team.

National cancelled all activities that were scheduled up to October 2020. They also adopted Resolution Number 3, which included cancelling the 2020 National Convention and keeping National Officers in place until 2021. The Department Executive Committee (DEC) has been communicating regularly to ensure Department functions safely and seamlessly throughout this process. First, the DEC voted on a motion authorizing the Department Adjutant to apply for the small business loan/grant, motion passed. At this

time of this article, the application is still pending.

The DEC also voted on a motion to cancel our 2020 Department Convention, motion passed. The Department worked hard with the hotel and finally got them to waive everything and charge us zero instead of having to pay the \$282,000+ cancellation fee. Thank you, Orlando World Marriott Center, for working with us and we look forward to 2021. All rooms that were reserved under the Legion Convention room block have been automatically cancelled. If you have any doubts or for verification, contact the Department Events Coordinator, Michael Bratsch, at mbratsch@floridalegion.org.

Next, the DEC voted on a motion to follow National's Resolution Number 3 and recommendation to keep all Department Officers in place until the next official Annual Convention in June 2021, and that motion passed. To properly solidify and document all of the Emergency changes resulting from the shutdown related to the COVID-19 pandemic, the DEC approved Department's Resolution 20-01 during a Special Executive Committee meeting held via Zoom on April 24th, 2020.

Mike McDaniel and the Department staff has been working their tails off during this time also as they always do.

Please make sure your e-mail is correct and on file with Department as we will still be sending a lot of information as it is posted. With that being said, Social Media has been going crazy lately with a lot of rumors being posted out there I hope that stops as it causes nothing but problems for everyone. If you have any questions, please e-mail them to us and we will get you an answer. Questions will not be answered on Facebook. Official notifications of things happening will be posted on the website and/or e-mailed to you. CPR's still need to be done by June 15th and Post Certification of Officer forms and Post Officer Reports are due by June 30th. Congratulations to the 15th Dist., 6th Dist. and 12th Dist. for being over 100% membership as we are very proud of you.

Please be safe out there and as we will reopen soon, please use common sense and do not put anybody in jeopardy. Do the right thing in good faith and we will not have a problem out there. PLEASE stay safe as me and my wife are praying for this to end and get back to some normalcy in the future.

I realize that a lot of you are concerned about our upcoming elections, both local



Pay our Coast Guard

On a daily basis our brave Coast Guard personnel carry out missions that are vital to our national security, yet the military branch working without pay during a government shutdown. The repeated and ubiquitous threat of government shutdowns brings server hardship on our Coast Guard men and women who do not have the same assurance of being paid as the members of the other armed services.

In order to conduct operations as normal, Coast Guard members need to understand that they will receive pay and allowances during government shutdowns. This assurance will ensure that servicemember charged with securing out homeland can concentrate on the task at hand.

KEY POINTS

- In January of 2019, over 41,000 active-duty Coast Guard servicemembers experience a 3-week long pay gap.
- The American Legion's Temporary Financial Assistance (TFA) program was able to provide more than \$1 million in non-repayable grants to approximately 1,713 Coast Guard Families with 3,170


children.

- The American Legion distributes one-time cash grants of up to \$1,500 to the minor children of eligible active-duty military and American Legion members in need.

WHAT CAN CONGRESS DO?

Supports bills and provisions that will ensure the Coast Guard is paid during government shutdowns. IS.21, H.R. 367, Section 221 of S.2297 Coast Guard Authorization Act of 2019.

We need your voice heard by contacting your Congressman and Senators and express your feelings that this is unfair to our brothers and sisters.

It is apparent that National Headquarters has not heard the cries from the leadership in the Posts and Departments regarding the acceptance of members into a private organization without a vetting process. In the past four weeks the renewals of Post 400 members back to that Post were 240 members. Not new members, renewals. The information you see below is National's application to the American Legion from their website.

Please select appropriate option before continuing:

Yes! I would like to join and am not currently a member.

I am a current or former member and would like to renew or rejoin.

Eligibility Information

If you have served federal active duty in the United States Armed Forces since December 7, 1941, and have been honorably discharged or are still serving - you are eligible for membership in The American Legion!

*Because eligibility dates remain open, all active duty members of the U.S. Armed Forces are eligible to join The American Legion at this time, until the date of the end of hostilities as determined by the government of the United States.

**U.S. Merchant Marine eligible only from December 7, 1941 to December 31, 1946 (WWII).

Nowhere will you find on that application a comment about requiring to show or send a copy of that individual's DD Form 214 or Honorable Discharge. Why is that? Yet these members come into the Posts pay a lower membership fee, most of the time, and benefit from a members only establishment. I'm not directing this to individuals that are legitimate veterans who have a DD Form 214 or Honorable Discharge but how do we know? When our Posts contact these members, and this year we made it a concerted effort in trying to transfer these members from Post 400 into a community closest to their homes, we get a few responses some of which I will share with you now.

- a. Ask the member to bring a copy of his/her DD Form 214, they respond with, "What's a 214?"
- b. Why would I want to pay a higher membership fee when I can pay \$25.00?
- c. Do you know of the many programs we offer to our communities? NO IDEA

Yet this year National Headquarters added 11,000 DMS/Post 400 members to our quota. Am I whining, maybe, but I ask you this, does that seem even remotely an

attainable goal? Are they not supposed to set our Posts and Departments up for success? Or for failure? This year, to date, PDC Ramos and I have taught membership classes focusing on transferring these members by any means possible including email with the stipulation that they agree to the transfer first. Getting these members back into the community serves as a vital role for the success of all our programs.

Now I will turn my focus to what has become the most difficult times of our American Legion in history, the COVID-19 pandemic. This comes at the height of our year affecting all of programs and the hardest hit is Americanism, mainly Baseball, Boys and Girls State and Children and Youth. Not to mention our elections process and conventions and conferences once that has been decided. With the guidance set by the Department Commander we have set out on a Buddy Check Program likes of which we have never seen before. Posts conducting deep cleaning and remodeling trying to keep employees and volunteers involved around the social distancing guidelines. As far as membership, already we have heard from members that they will not renew until Posts are reopened.

WE will survive this!! As a team we can survive anything. Keep your hearts and minds open and work together. Stay focused.

the local post-level via "virtual" or "technology" media is to keep everyone informed of what is happening, while offering a quick and easy means to let members know your plans for when things start opening back up? There



A Day of Pandemic as told by NYPD Officer

I recently received this in my E-Mail from one of my brothers from The Blue Knights Law Enforcement Motorcycle Club. It is fairly long but a great read and applies to all of our First

Responders.

What a mess in NYC.

Please pray for our Brothers & Sisters in NY.

Stay safe!

I pray that our brother and sister officers and their families stay safe. Unfortunately, we know we are going to lose more. Please share for those that don't use FB. It is a grim eye-opening experience of what they are living:

Sent in by an NYPD Officer.

What it's like being a police officer in NYC on 4/10/2020

You start the tour like any other. Standing roll call waiting for your assignment. You look to your left and right and realize today that even more of your coworkers

are not here. More friends out with the sickness. You think to yourself; they are strong. they'll be ok. You listen to the sergeant give out assignments. Half of the platoon is being assigned to relieve the earlier tour who are taking reports for DOA (dead on arrival). This is common during tour change now as it's been taking the Medical examiner anywhere from 6-10 hours to come to collect the bodies. It used to be a 1-2 hour wait. Now it's you're whole tour. In my patrol area we used to get maybe 1 DOA a month during midnight tour. Now we get 5-8 every night. You head out for patrol with your partner. The streets are eerily quiet. You make your normal rounds and

find a place to park and wait. Your job phone goes off with notification after notification of ambulance calls for people with corona virus. Most of them start the same, person with cough, fever, tested positive or symptomatic for Covid -19, awake and conscious having difficulty breathing. You've been instructed not to respond. Let EMS handle it they are properly trained and have better PPE. Once an hour the phone goes off with a code change. That last ambulance call, CPR being performed. 1/2 hour later another CPR, 1 hour after CPR again. They died in their homes. Units get assigned to go take the reports. It's not a lot of paperwork but we know they'll be out for the remainder of tour awaiting the medical examiner. More units assigned to DOAs. We're being spread thin. Trying to console grieving families with a mask on your face is no easy task.

You cover jobs out of your sector as well as your own. You get a 911 call for

someone having a violent mental episode. Great, now you need to transport them with EMS for psychological evaluation at the hospital. The last place you want to be. You don't want to use the EMS and hospital resources if you can help it because they are busy trying to save lives. Sadly, you have no choice. Now you're at the hospital with an irate emotionally disturbed person in custody. Stop. Look around. Everyone is coughing. You're in the emergency room. The same room all Covid patients enter. Should I wear 2 surgical masks? I think one of them is new. Hard to tell I've been rotating the same few masks for weeks. Will it matter? We'll be out of the hospital soon. Phew back in the car. Sanitize. Wait did I get any virus on my uniform from the ambulance ride? I sure hope EMS had enough wipes to clean the ambulance I rode in.

You spend the rest of the night answering jobs. You touch door handles, elevator buttons and people who need help. You never realized how many things or people you touch throughout your tour. You wash your hands every chance you get. Your knuckles are cracked. The Sanitizer burns your open skin. Doesn't matter though. Have to stay healthy. Have to slow the spread. Have to come to work. Have to help people. It's 7 am now. You hand the keys off to the day tour and say good luck. You know how many people will be waking to check on their loved ones and find them unresponsive. The day tour will be stretched even thinner. As soon as you get home it's time to shower. Shoes off outside. Uniform in a garbage bag or right into the laundry if you're lucky enough to have the amenities. Finally, at home, clean and safe. Just don't get too close to the spouse, kids or pets. I definitely don't have it, you tell yourself..... I probably don't have itI hope I don't have it. Have to get to bed so you can wake up and do it again tomorrow.

However, they are doing their best to accommodate and support PROJECT: VetRelief's Suicide Prevention Initiative (SPI) in these uncertain times. Their goal is to **still** raise \$50,000 for the program.

They have been challenged to ride 22 miles for the 22 veterans who take their lives every day sometime before May 22nd. American Legion Post Commanders and Adjutants,

A statewide stay-at-home order that Gov. Ron DeSantis announced on March 24, 2020 in response to the coronavirus pandemic is now in effect. Executive Order 20-83 urges the public to avoid all social and recreational gatherings of ten or more persons. The executive order also directs all Floridians to limit movements and personal interactions outside the home to only those necessary, to obtain or provide essential services or conduct essential activities.

Due to this order our posts are closed and we find ourselves seeking for a way to conduct our annual post elections.

The attached document contains suggested ideas for posts to conduct nominations and elections during this period. The posts must decide what is best for you.

I urge you to complete this in a way that is fair and that takes into account the needs of all members. Every member in good standing has the obligation and the right to vote for officers of the post. Every effort should be made to not dis-enfranchise any member.

I also urge everyone to be mindful of the preamble to our constitution, "TO CONSECRATE AND SANCTIFY OUR COMRADESHIP BY OUR DEVOTION TO MUTUAL HELPFULNESS." This is how we can hail The American Legion today as an unparalleled force in these United States for social betterment. American Legion concepts and its ideal of devotion to mutual helpfulness warmed up the whole social climate of America. Let's not forget that tradition by doing all we can to help each other.

Stay safe during this crisis and be mindful of those that need our help.

THESE ARE POTENTIAL OPTIONS AND ARE ONLY SUGGESTIONS AND RECOMMENDATIONS. POSTS NEED TO MAKE THEIR OWN DECISIONS BASED ON WHAT IS BEST FOR THEIR MEMBERSHIP.

POST NOMINATIONS AND VOTING

The biggest issue in this entire process is fairness and communications.

A Post **must** make a good faith effort to reach their **entire** membership and inform them of the steps to both nominations and elections. *Those steps are:*

NOMINATIONS: When will nominations process start and how that gets done and a cut-off date.

ELECTIONS: The date when elections will take place, how it will be done, when it begins, when it ends.

Also, it is strongly suggested depending on how you do elections, that if you are actually counting physical ballots and not using an online method that they be secured and opened at a separate time when all members can come and watch the count from their cars (depending on the restrictions currently in place) if desired. Some of your members you can reach by email, others by phone and all the rest by mail. However, you choose to do nominations, elections and posting of the results the procedure must be reasonable and fair to all Post members.

Under the COVID 19 crisis the methods of running elections should be decided by the following procedure.

NOMINATIONS

- nominations are required, even in this crisis. Self-nominations are acceptable (Write In). Seconds of nominations are not required per Roberts Rules of Order, Newly Revised.
- Not required to be read at one, two or three meetings prior to election!
- In all situations nominations are allowed at the time of election *using the write in space.*

Therefore, there are several options which a Post can use to take nominations, but the membership must know the start and cutoff date for nominations.

A Post can take Nominations and can be made by:

- email from the member to the Adjutant or the nominating committee if you so advise your members of the Adjutant's email address.
- by a phone call to the Adjutant or the nominating committee, if his phone has voice messaging and the members have his phone number and extension.
- by a sign-up sheet on the front door if you have informed the membership that the signup sheet is there.

BALLOT

- After the cutoff date for nominations, review the nominees to insure each one is a member in good standing of your Post
- Once you know the candidates that are in good standing, you will prepare a ballot listing each office and the members who are running for that office. That ballot must include a space under each office so that a member can "write-in" a candidate that may not have been nominated through the nomination process.
- Make certain you put a space for every officer even if there are no nominations because each will have a "write-in" space any member could write themselves in for that open position

ELECTIONS – you have several options available

- Simply Voting (www.simplyvoting.com) is an online application which is low cost, provides for the Post Adjutant or whomever else the Post appoints to administer the election to input the membership data and an election ballot. You would go to the Application on-line, members could perhaps use their 9-digit membership number for authentication, after authentication, ballot comes up, vote, release your ballot, your done. You can't vote again.
- Next option could be a drive-in ballot where members pull up in their car to a location, Adjutant or whomever checks to make sure they are a member, provides them a ballot, they vote the ballot and place it in a ballot box the Adjutant or whomever collects ballot boxes and then on another day at a predetermined time and place the ballot boxes are opened and counted.
- Open the Post, for 5 or 6 hours to allow members to come in for voting only. Member comes in, maintaining social distancing, check-in to ensure

they are a member in good standing, get a ballot, vote the ballot and place ballot in a ballot box and leave.

REPORTING RESULTS: To maintain transparency we strongly recommend that the results of the election be reported in a separate meeting, possibly in the parking lot where members could watch the opening and counting of ballots from their cars. After the count is complete and verified the results of the votes announced and then post the results. If you use an online tool or other means you could mail, email or simply report the results at a separate meeting. Just make sure that you afford all members the opportunity to vote and give all of them the results of the election. PLEASE REMEMBER No matter which of these options you choose, the option must be communicated to your entire membership, everyone must know when, where and times so everyone has the opportunity to participate.
