
Enough of all that, my wife and I just want to wish everyone a Merry Christmas and a Happy New Year.

What a year - with COVID-19, closing Posts, opening Posts and then closing and then reopening of the Posts, and now a 2nd wave of COVID-19 is occurring. We have our work cut out for us. Currently we all should be doing a "Buddy Check", reaching out to the members who have not visited the Posts in a while. Ensure that they are ok or find out if they are in need of assistance, and invite them down to the Post. Those who do the Buddy Check find out that members want to hear from us, often those who are nervous about

COVID-19, do not want to leave their homes, we have a chance to invite them down for Christmas and ask them to join the celebration. In January/February a 2nd Buddy Check should take place; this is where you should ask about the dues as well as how they are doing.

Commanders, you should be documenting your accomplishments on the online CPR's. This a way for you to keep track of what you do within your Post. If you don't track your Post's accomplishments, you may have forgotten something. You may think this may be a small item or detail, but with the other items that are forgotten, it adds up. Use the Online CPR's to help you track what you are doing, what you are giving.

The American Legion Child Welfare Foundation Grants

The American Legion Child Welfare Foundation received 174 grant applications seeking consideration for a 2021 CWF grant by the Board of Directors. Following a review

with the screening committee, the board approved awarding 19 grants totaling \$740,889 for the 2021 calendar year.

The foundation recorded contributions totaling \$503,223.42 for the 2019-2020 program year (June 1, 2019 – May 31, 2020). The Sons of The American Legion (SAL) contributed over \$252,944 for the 2019-2020 program year; the SAL contributions comprised 50% of the total program year donations.

The CWF Foundation received its first distribution from Amazon Smiles this past August. A total of \$36.02 was donated to the foundation by Amazon purchasers having designated contributions toward the CWF.

The "Sons for Kids" Aprons and the CWF Piggy Banks are available through the CWF at National Headquarters.

New Insurance Requirments, Resolution 35

ADOPTED BY THE NATIONAL EXECUTIVE COMMITTEE AT A VIRTUAL MEETING HELD OCTOBER 14 -15 AND WHAT IT MEANS TO EVERY POST WITHIN THE

DEPARTMENT OF FLORIDA

The National Executive Committee (NEC), without consultation with any of the Posts in the organization which has become the procedural norm, has approved the following resolution which will affect every Post in The American Legion. Below are the resolved clauses of Resolution 35

RESOLVED, By The National Executive Committee of The American Legion in regular meeting assembled virtually on October 14-15, 2020, That because The American Legion owns, controls, protects

and defends The American Legion’s Tradenames, this resolution is necessary to dictate protective standards over the Tradenames; and, be it further

RESOLVED, That The American Legion, via insurance policies, protect itself, and its Tradenames, from liability and subsequently strongly urges all American Legion departments, department-chartered intermediate bodies and posts do the same; and, be it further

RESOLVED, That due to the need to protect The American Legion’s Tradenames from liability it shall be required forthwith that when any American Legion department, department-chartered intermediate body, post or organization use The American Legion’s Name or Tradenames and an insurance policy is obtained, the group utilizing this insurance policy shall specifically in the insurance policy hold The American Legion harmless and named as an additional insured on any, and all, insurance policies; and, be it further

RESOLVED, That The American Legion’s

national adjutant, or designee, has complete authority to independently investigate, confirm and report that any, and all, insurance policy(ies) purchased by an American Legion department, department-chartered intermediate body, post or organization shall specify that The American Legion is held harmless and named as an additional insured on any, and all, insurance policies; and, be it finally

RESOLVED, That The American Legion’s National Executive Committee strongly urges that all American Legion departments follow similar courses of protective action, to wit: (1) require all of the department’s own intermediate chartered bodies and posts that obtain insurance policies hold their respective

American Legion departments harmless and also named as an additional insured on any, and all, insurance policy(ies) and (2) that the department adjutant, or said designee, have the complete authority to independently investigate,

confirm and report that any insurance policy(ies) purchased by the department's intermediate body or post shall hold its respective department also harmless and named as an additional insured on any, and all, insurance policies.

What does this mean to a Post?

Let's define some terms, what is Hold Harmless? A legal definition of hold harmless: is an agreement between parties in which one assumes the potential liability for injury (Post) that may arise from a situation and thus relieves the other of liability (The American Legion and AL Department of Florida). Say someone falls in your parking lot, breaks a shoulder, or is overserved in your Post and leaves, getting in a serious accident. Lawsuits follow. Under a hold harmless the Post is solely responsible for the lawsuits both Department and

National are protected from liability under the hold harmless. This "hold harmless" for The American Legion and The American Legion Department of Florida must be added to every insurance policy a Post holds in its name (General Liability, Liquor Liability, Property, Directors and Officers and Fidelity Bonds).

The next new term applies more to liability insurance, but an additional insured would have their names (The American Legion and AL Department of Florida) listed on all your insurance policies. Should a lawsuit or any other claim occur the Post is held liable, and the additional insured is protected, and should the additional insured incur costs they would be reimbursed by the insurance company.

Usually additional insured is commonly used in conjunction with an indemnity agreement (like Resolution 35) between the named insured (the Post) and the party

requesting additional insured status (The American Legion and AL Department of Florida). Every insurance policy held in a Posts name, must specifically reflect The American Legion and The American Legion Department of Florida as named additional insured.

The additions required under Resolution 35 are being implemented because the tradename The American Legion and the Logo of The American Legion are assets of the organization and require legal and financial protections through insurance coverage at all levels of the organization.

Please re-read the 4th Resolved clause as this will be the mechanism to assure compliance by Posts and Departments. I expect the Department Adjutant will be charged with monitoring compliance by every Post within the Department. Exactly how, has yet to be determined.

In the month of December, we have many things to honor and celebrate. Pearl Harbor Day December 7th to remember and honor the 2,403 citizens of the United States who were killed in the

Japanese surprise attack on Pearl Harbor in Hawaii on December 7, 1941.

Hanukkah is a Jewish festival commemorating the rededication of the Second Temple in Jerusalem at the time of the Maccabean Revolt against the Seleucid Empire. It is also known as the Festival of Lights. Hanukkah is observed for eight nights and days, starting on the 25th day of Kislev. The festival is observed by lighting the candles of a candelabrum with nine branches, called a hanukkiyah. One branch is placed above or below the others and

its candle is used to light the other eight candles. This unique candle is called the shamash candle. Each night, one additional candle is placed from right to left and is lit by the shamash from left to right until all eight candles are lit together on the final night of the festival.

Christmas December 25th is the celebration and remembrance of the birth of Jesus Christ. Jesus was born in Bethlehem, in accordance with messianic prophecies. When Joseph and Mary arrived in the city, the inn had no room and so they were offered a stable where the Christ Child was soon born, with angels proclaiming this news to the three kings and they followed the star they had seen in the east ahead of them until it stopped over the place where the child was. When they saw the star, they were overjoyed. On coming to the house, they saw the child with his mother Mary, and they bowed down and worshiped him. Then they opened their treasures and presented him with gifts of gold and of incense and of myrrh. The Old Testament,

written hundreds of years before Jesus' birth, contains over 300 prophecies that Jesus fulfilled through His life, death, and resurrection. Our Savior was born!

Kwanzaa is a week-long annual celebration held in the United States and other nations of the African diaspora in the Americas to honor African heritage in African-American culture. It is observed from December 26 to January 1, culminating in gift-giving and a feast.

As part of our Challenge 22 efforts, I have been in contact with the American Association of Christian Counselors and we are being offered a faith based Mental Health Life Coach Certificate through Legion Church. It is about 45 hours of online training and the \$2400 tuition has been waived, so the only cost is a \$54.00 administration fee. I have been asked by numerous people why I have not contributed to the Legion Link over the course of the last 7 or eight months, the reason is quite simple...

I have had nothing worth saying.

As the year winds down, I have plenty to say.

As a Department, COVID hit ALL of us hard! Posts, small and large, suffered through the numerous shutdowns. I never wrote an article about COVID, because I believed our Department Commander covered everything with his numerous posts on social media and the Department website. As the Department Historian, what else could I add? In retrospect, I could have written an article about watching your fellow Legionnaires' back, instead of raving them out on Facebook. The single-mindedness being displayed on social media during this crisis is quite disheartening.

Which brings us to our History lesson of the month...

At the 1976 American Legion national

convention in Philadelphia, Pennsylvania, one hundred and eighty-two American Legion members acquired pneumonia from a previously unknown strain of bacteria now named "Legionella". Of those 182 Legion members, twenty-nine died. Between 1995 and 2005 over 32,000 cases of Legionnaires' disease were documented. Since that time, there have been dozens of documented fatalities caused by "Legionnaires Disease." So, ladies and gentlemen, how many Veteran Service Organizations have their own infectious disease named after them?

Based on that little piece of history and our current Coronavirus situation, decisions had to be made on the Department level regarding special events.

We did not have a Convention. Not the worst thing in the world, but elections would have been nice. We did not have a Fall Conference. Not a real big deal. Classes have been done over video conferencing in the last month or so. All taken care of.

However, to see the vitriol being spewed on social media because Legion members were not able to go to Orlando for a weekend of drinking and socializing makes my head spin. I suppose the attitude among some Legionnaires is, "who cares about the welfare of our members? We need a reason to party!" Edmond Burke wrote, "those who don't know history are doomed to repeat it." For those reading this, I have a simple question. Would you

be willing to gamble with your life or your fellow Legionnaire's life for the sake of visiting a few a hospitality rooms? If you cannot answer the question, do not complain about the people that had to make the tough decision of cancelling the convention and conference.

Most recently, the Department held a leadership retreat. Based on the social media posts I have read and been the subject of recently, many unsatisfied Legionnaires were not happy because they were not invited. However, the ones complaining the loudest are the same ones that I have not seen during my travels around the state over the last eighteen months. I say to them, "step up and do your job, then maybe you will be invited to teach and contribute."

Me, I can rest easy knowing that I have tried to the best of my ability to cover as many events as I can, and to teach when called upon. I have done my best to represent our Department on a local and national level. This month's column will not be popular with a lot of people within our fine state. I can live with that. My goal for all the Districts in the Northern Area, is 100% by St. Patrick's Day. This is due to the Race to the Top deadline being set at March 31, 2021. This award is a national membership award that recognizes the top District Commander in five membership categories. More information on Race to the Top can be found in the Department Membership Manual.

Does your Post have members that have not renewed for 2019 or 2020 (last 1-2 years)? Contact them. Are there Post 0400 Members & DMS Members in your area? Use MyLegion.org to find out, then contact them.

Is your Post going to be hosting a children's Christmas party? Look around your Post for a Proper Santa. Beard & Belly are a plus, but the most important quality of a Santa is love of children. While the party is on, look at the parents for indications that they are eligible for the American Legion, (such as a hat, belt buckle, necklace, earrings, tattoo, etc.) and ask them to join.

Here are a few reminders and other important dates:

1. Boys State Delegate fee - \$450 per Delegate - is due before January 6, 2021.
2. Post Level Oratorical Contests must be completed January 2 – January

17, 2021. That means you should be conducting and finishing your candidate selection process this month if you have not already done so. District Oratorical dates: January 20 - February 7, 2021. Area Oratorical dates: February 8 – 21, 2021. Department Oratorical will be held March 13, 2021 at Department Headquarters.

3. Now is the time to start planning a Four Chaplains Memorial Service. This Honors Four Army Chaplains that gave up their lives on February 3, 1943, when the U.S.A.T. Dorchester sank.
4. Spring is coming. That means Shooting Sports, School Medals, and the ALR Summit.
5. The Northern Area Ball will be held on March 6, 2021, at American Legion Post 129 in Jacksonville Beach. Look for the Flyer on Department website.
6. Regardless which Religious Holiday you celebrate, Have a Happy & Safe Holiday Season.

Continue to plan for February please look at the timetable plan.






Think Ahead for Membership

The Coronavirus outbreak has forced our Posts to reevaluate how employees deliver relevant customer experiences, where they work, and how digital channels can be used to support

business continuity through the crisis and beyond. The global COVID-19 pandemic has forever changed our experiences as customers, employees, citizens, humans and our attitudes and behaviors are changing as a result. The crisis is fundamentally changing how our members react and it takes a leadership role to make sure we are doing the right thing in protecting our members. Once

the immediate threat of the virus has passed, Posts will need to consider the impact of these changes on the way we communicate, build, and run the experiences that people need and want. Our membership will depend on it.

Department wide we have 21 Posts currently at or over 100%. In the Southern Area they are Posts 390, 317, 32, 26, 413, 268, 367, 390, 99 and 147 as of the November 12th Report. The National Report shows us at 2,346 renewals ahead of where we were this time last year (Again this is a November Report). Also, as of the weekly report of November 12th, Post 400 is reaching 79%. There are still 2,500 members you can reach out to that have not renewed. Chances are they are waiting until the last minute to renew so that gives you a short window to reach out to them and invite them to your Post.

Some dates to remember this month: 75% Goal by December 2nd. The day after Thanksgiving kicks off the Holiday Blood Donor month that last until December 31st. The 13th of December is the National Guard's Birthday which is a good time to reach out to the local National Guard unit and do a holiday meal at your Post. On Saturday, November 14th, 2020 the American Legion Post 63 held its 4th Annual Challenge 22 Ruck Walk and Suicide Prevention event in Winter Garden Florida benefitting PROJECT VetRelief.

With the help of a tremendous team of volunteers, many of who had no affiliation with American Legion or its family, we were able to put on an event while alerting the community to the crisis faced in the veteran community while having a ton of fun doing it. Many The opportunity to get outside and be part of something in our communities once again meant so much to many of our participants. This year we had between 220 and 275 walkers participating in the walk as well as an additional 150-200 attendees who weren't able to participate in the walk. Overall, about 450 attended for the day. The actual amount raised is still being tabulated, but once complete, we will let you know as all these funds will go towards helping save veteran lives.

We were honored to have the American Legion National Judge Advocate, Kevin Bartlett, as well as the National Media and



Communications director, Jeff Stoffer, in attendance. We were able to tell the story of the great things that the Department of Florida is doing to end veteran suicide in a way that hopefully will reach many.

In addition to an "in-person" event, this year Challenge 22 offered a "virtual" option. And though it was only our first year attempting to do this, via the power of social media, we had participants from all over the United States, including Puerto Rico, California, and Oregon.

Hearing the words from our guest speaker, Dr. Damon Friedman, it brought home the story of the trained the warrior who is given the tools to fight the battles we face from a physical enemy. Unfortunately, we have a long way to go in getting our veterans the tools they need to face the battles from the trauma experienced in carrying out those critical missions.

We also heard from two of our "younger" veterans, who both celebrated their birthday this weekend. Mr. Mel Jenner, a

WWII veteran who served as a crewman in over 45 combat missions including flights over Berlin, and who suffered from post-traumatic stress (PTS) for over 50 years, told his story about how he and his friends served their country. Mel celebrated his 98th birthday. We also honored Gilbert Waganheim. He too shared his story about how he did his best to liberate the concentration camps and Europe from Nazi fascism while serving in Patton's 3rd Army.



We celebrated his 99th birthday. Gilbert also actually participated in the walk, as he is done for the last three years.

The Challenge 22 events are fundraisers to engage our communities while raising money and awareness to the fact that we

Research on Blood Type & COVID-19

Two studies published today in Blood Advances suggest people with blood type O may have a lower risk of COVID-19 infection and reduced likelihood of severe outcomes, including organ complications, if they do get sick.

As the pandemic continues, the global biomedical research community is working urgently to identify coronavirus risk factors and potential therapeutic targets. The potential role of blood type in predicting risk and complications of COVID-19 infection has emerged as an important scientific question. These new studies add evidence that there may be an association between blood type and vulnerability to

COVID-19; however, additional research is needed to better understand why and what it means for patients. INDIVIDUALS WITH BLOOD TYPE O MAY BE LESS VULNERABLE TO COVID-19 INFECTION

Blood type O may offer some protection against COVID-19 infection, according to a retrospective study. Researchers compared Danish health registry data from more than 473,000 individuals tested for COVID-19 to data from a control group of more than 2.2 million people from the general population. Among the COVID-19 positive, they found fewer people with blood type O and more people with A, B, and AB types.

The study results suggest that people with blood types A, B, or AB may be more likely to be infected with COVID-19 than people with type O. The researchers did not find any significant difference in rate of infection between A, B, and AB types. Since blood group distributions vary among ethnic subgroups, the researchers also

controlled for ethnicity BLOOD GROUPS A AND AB ASSOCIATED WITH INCREASED RISK OF SEVERE CLINICAL OUTCOMES OF COVID-19 INFECTION



People with blood groups A or AB appear to exhibit greater COVID-19 disease severity than people with blood groups O or B, according to a separate retrospective study. Researchers examined data from 95 critically ill COVID-19 patients hospitalized in Vancouver, Canada. They found that patients with blood groups A or AB were more likely to require mechanical ventilation, suggesting that they had greater rates of lung injury from COVID-19. They also found more patients with blood group A and AB required dialysis for kidney failure.

Together, these findings suggest that

patients in these two blood groups may have an increased risk of organ dysfunction or failure due to COVID-19 than people with blood types O or B. Furthermore,

while people with blood types A and AB did not have longer overall hospital stays than those with types O or B, they did remain in the intensive care unit (ICU) for a longer average time, which may also signal a greater COVID-19 severity level.

Many of you have wondered whether you can or cannot give blood. The chart below shows the medications that would disqualify you and the deferral status


Truth is, since COVID-19 our funding has gone out a lot faster than it has come in. We *will not* be able to continue this level of support without your help!

With conditions being what they are, our hospital and CBOC reps still aren't able to resume their normal volunteer duties to a great extent. I encourage all to sign up for the VA News online publication for advance notices of these virtual events.

Another important announcement, this one coming from the Department of the Interior and specifically for Veterans and Gold Star families. Beginning Veterans Day November 11 and going forward, entrance to all the National Parks, wildlife refuges and other lands managed by that Department is free with proper forms of identification. This makes available access to approximately 2000 locations nationwide.

In closing this month's article I'm asking everyone to remain mindful and vigilant of not only the pandemic we face but that we're all in this together so continue to reach out to any veterans who need some help getting through it all.

as the largest veteran's organization in the area and due to its commitment to veterans and community support for ongoing activities.


