At the general membership meeting held at Post 186 on August 5th, 2021, the membership unanimously approved the endorsement of Bruce Carl for the office of 3rd Vice Commander for the Department of Florida.

On a Post level, he has served in every position except Historian and Finance Officer. He has also served on the CB&L committee, House Rules Committee, E&N Committee, as well as various other committees. He also advocated and brought the Adopt-A Highway program to our Post.

On the District level, he has served as Assistant Chaplain for 4 years, Children and Youth Chairman for 6 years, Membership Chairman for 2 Years, Vice Commander for 5 years, and District Commander for 3 years. During his 3 years as District Commander the 15th District achieved over 100% in membership, including winning Category IV District Commander Race to the Top for the years 2019-2020 and 2020-2021.

On the Area level, he served as the Central Area Americanism Chairman 2020-2021, and he is currently serving as the Central Area Commander.

On the Department level, he served as the Children and Youth Chairman for the Department for 2017-2018. Currently he is serving on the National Convention Committee for the 2025 National Convention in Tampa.

On the National level, he is serving his second year on the Americanism Council and represented Florida at the Americanism meetings in Indianapolis this past October.

Bruce has completed Lead Training, American Legion Institute, Basic Training, and has attended training for all offices in the American Legion and is a graduate of The Florida American Legion College. He has attended/and or held all District and Area Training sessions, as well as Department Convention and Fall Conference for the past 10 years. He has also attended some National Conventions.


