to help our mission to make a better American Legion for all of us. If you are already a member, just double-check to ensure you are still active.

#### One Legislative issue still going is Flag Amendment:

"The U.S. Supreme Court ruled that flag desecration is protected speech after a self-proclaimed communist was charged with desecrating the U.S. flag. The 1989 Texas v. Johnson case invalidated the law against flag desecration in 48 states and the District of Columbia. The American Legion and veterans were outraged that the Court, in a 5-4 ruling, took away the fundamental right for the people to protect their flag."

#### Resolution No. 19: Flag Code Amendment.

The American Legion strongly supports a constitutional amendment that would return to the states the right to protect the U.S. flag. And yes, I'm 100% to protect our great U.S. flag that I fought for 20 years in the U.S. Army. Are you with me? For more information, email cfa@legion.org.

#### National Security is just something going on the list below:

End Forever Wars: The American Legion National Executive Committee unanimously passed Resolution No. 22, Addressing "Forever War," at its virtual meeting on Oct. 14-15, 2020. The resolution encourages Congress to "repeal and replace outdated authorizations for the use of military force" and advocates for a "civilian-led approach of elevating development and diplomacy alongside a strong defense in order to build a better, safer world."

**POW/MIA Accounting:** The American Legion continues to support total funding for the Defense POW/MIA Accounting Agency (DPAA) in its mission to recover, identify or account for fallen American servicemembers from battlefields worldwide.

Pay Our Coast Guard: Because the U.S. Coast Guard falls under the Department of Homeland Security, its funding is often not approved as early as the DoD branches of the Armed Services. The American Legion believes that Congress should pass legislation to ensure that members of the Coast Guard do not experience pay interruptions in the event of future government shutdowns.

Meanwhile, all commissions will cooperate to assist in preventing veteran suicide.

#### Restricted and Unrestricted Funds

Could you, as a Post Officer, misappropriate funds without realizing it?

When dealing with donations, the funds received can only be used

for the purpose stated when the funds are received. Designated purposes can be indicated on the memo line of the check (i.e., "American Legion Boys State Program transportation"), a letter received with the donation stating the funds are for school medals, or an auxiliary member sets up a donation jar/pass the hat and states the donations will be used to help pay to replace a broken appliance in the Post's kitchen.

I have provided additional information below to help clarify how donated funds are classified.

There are two types (or buckets) of funds, restricted and unrestricted.

Restricted Funds: These funds are set aside for a particular purpose. Sometimes it's temporarily restricted, meaning that the restriction could end due to a specified time limit or, more likely, by the completion of a project, such as the construction of a facility. Funds that are permanently restricted are usually meant for ongoing projects or activities with no time limit (i.e., the Post has a building fund that is used to maintain the Post facility). Alternatively, a permanent restriction could also be tied to money that is to be saved or invested in an endowment fund, the interest earnings of which can be used for a particular activity or general operations.

Unrestricted Funds: As the name suggests, unrestricted funds don't have strings attached and may be used by the nonprofit for whatever purpose it deems necessary. This money typically goes toward normal operating costs—an example, if your Post membership dues are \$40. \$29 of the membership dues received are restricted funds (Part must go to the Florida Dept. and part to National). The remaining \$11 dollars are unrestricted funds and can be used to pay for various Post expenses/programs.

It is important to remember that restricted means **RESTRICTED!** This is not a trivial matter. Donors can take legal action against a nonprofit that the donor believes is misusing their restricted donation. The last thing your charity wants is to be in the cross-hairs of the state Attorney General's office.



The American Legion, Department of Florida is no stranger to massive destruction caused by natural disasters.

Because of this, Legion Families across the United States pitch in to provide necessary, and sometimes live-saving, support to help us rebuild or repair our lives, homes, and Legion establishments. #### **Proper Display of Flags and Military Salute**

First, I want to thank all the Posts that supported me in my bid for re-election as your Department Sergeant-at-Arms. It is greatly appreciated, and I plan on representing ALL Posts in our Department. And remember, if you

want some Sgt-at-Arms training for your district, please let me know.

In the meantime, I am going to use this forum to provide some answers to some of the questions I have been asked over this past year. Here are three of them. "Can the members of the S.A.L. give the military salute? The S.A.L. is only authorized to render the military salute when wearing their official S.A.L. Cover. If they do not have their S.A.L. cover on, then they must salute with their right hand over their heart. I have been to many District and Post meetings and installations around the state and have seen members of the S.A.L. rendering the military salute with no cover on or a ballcap on.

"Being that the Riders are a program of the American Legion, can the Auxiliary members and Sons that are not

dual members (see the answer to Sons above) give the military salute?" The answer is NO. Before you were a rider, you were either an Auxiliary or Sons member. You follow the rules associated with your particular unit in the American Legion.

"What is the proper order to display flags at meetings or in a display at the Post."

#### Order of Displayed Flags (Peace Time)



Even though the Coast Guard is older than the Space Force and Air Force, it does not fall under the Department of Defense. It is part of Homeland Security. This is why it is displayed last.

#### Order of Displayed Flags (Times of War)



During a time of declared war, the Coast Guard then became part of the Department of Defense.

#### Displaying Flags in Your Meetings



When using the POW/MIA Chair, there is no need to display the POW/MIA flag on a stand. If you are not using the POW/MIA Chair, place the POW/MIA flag to the left of the American Legion Flag.




## "TO FOSTER AND PERPETUATE A 100 PERCENT AMERICANISM"...

as a partner and get all types of canned goods, toiletries, water, first aid supplies, and similar items. I am a registered partner locally and simply call up to place an order. It's free.

- Local Churches: A large Catholic church in my area does a food drive for me twice a year. It's always at least 2000 lbs. of canned goods.
- Local Organizations: Knights of Columbus, HOA groups, Veterans groups, motorcycle clubs, and other organizations are great to partner with.
- American Legion Posts: Posts and other Veterans Service Organizations can host collection bins.

- VSO: Your local Veteran's service office.
- Think Outside the Box: You've got some ideas now, what else can you come up with?
- Storage: Obtain a storage facility, either space at the post or offsite. Ask your post to pay for the storage, and it counts as VA&R for reporting.

Did you know the 3rd Friday of September is the National POW/MIA Recognition Day, which was established in 1979 through a proclamation signed by President Jimmy Carter? Since then, each subsequent president has issued the same annual proclamation.

As such, on the national level, a ceremony is held annually on the National POW/MIA Recognition Day, which is the third Friday of September. Traditionally a ceremony is held at the Pentagon, which features members from each branch of military service and participation from various high-ranking government officials.

In addition to the national-level ceremony, National POW/MIA Recognition Day observances are held across the country on military installations, ships at sea, state capitals, schools, Veterans' facilities, and hopefully at many American Legion Posts throughout our 55 Departments.

No matter where they are held, these National POW/MIA Recognition Day ceremonies share the common purpose of honoring those who were held captive and returned and those who still remain missing.

Since 1999, the POW/MIA Accounting Agency has created a poster commemorating National POW/MIA Recognition Day. The annual edition of the poster continues to honor this tradition. You can order your 2023 poster at: <a href="https://dpaa-mil.sites.crmforce.mil/dpaaFamWebPosters">https://dpaa-mil.sites.crmforce.mil/dpaaFamWebPosters</a> they are free to you and your Post.

Now I want to ask you, what are you and what is your Post doing for the National POW/MIA Recognition Day/weekend? Many locations will honor the memory and plight of our POW/MIAs on the traditional third Friday, 15 September; however, several localities will hold their event on the 3rd Saturday, 16 September, to allow more participation in their working community. That is the case in Jacksonville, where we will be holding a Seven Bridges POW/MIA Remembrance Ride and follow-on ceremony on

Saturday, September 16th.

If possible, please join your Department of Florida Officers who will be traveling to Jacksonville for the 3rd Annual Seven Bridges POW/MIA Remembrance Ride & Ceremony. I encourage any who can attend to please do so. The ride is awesome, and the ceremony is quite moving. This year we expect Mrs. Meghan Wagoner, Scott Speicher's daughter, to be a special guest in attendance. For those of you who do not know, Scott Speicher was the first person to be shot down over Iraq during Operation Desert Storm on 17 January 1991. His remains were not recovered until 2 August 2009. He was assigned to a Squadron that flew out of Cecil Field Naval Air Station, where the National POW/MIA Memorial is located. A F/A-18 with his name immortalized on the cockpit is on display at the memorial.

**Immigration Legalities** 

Thank you, Mr. Commander, for allowing me to continue as the Department Immigration Chairman. I want to refresh and update Florida

Legionnaires on the status of foreign-born non-citizen U.S. Marine Paul Canton. I have been working on Mr. Canton's case for about five years now. Let me refresh. Mr. Canton came to the United States from Australia under a student exchange visa back in the early 1990s. Mr. Canton liked what he saw and was interested in remaining in the United States. He explored ways to obtain citizenship and elected to serve in the United States military.

Mr. Canton joined the United States Marines on a delayed entry program. The United States military became involved in an armed conflict in the Middle East. Unfortunately for Mr. Canton, the active conflict status was lifted before he actually reported to basic training. This occurrence has affected the current status of Mr. Canton today. Nevertheless, Mr. Canton served in the United States Marine Corps for four years and

then served three years in Marine Corps Reserves for a total of seven years of service to his newly found country. According to Mr. Canton, remembering what his recruiter told him, he assumed he was a U.S. Citizen and lived his future life accordingly. He marries a U. S. Citizen and starts a family.

Mr. Canton became gainfully employed and paid his share of taxes. He obtained his driver's license. He was even given a voter registration card. How did he do these things? He used his DD-214, Certificate of Release or Discharge from Active Duty in the United States military, all the while thinking he was now a U.S. citizen. Unfortunately, some voter registration clerk's error cost him later down the road. Everything was going great until Florida required Mr. Canton to come in to renew his driver's license. At this point, he had no valid documentation to prove citizenship other than his DD-214 (which he thought was his ticket to citizenship). Unfortunately, for whatever reason, he had not completed the remaining steps for naturalization once he left military service. I am not convinced he was instructed by the Marine Corps out processing what he had to do to obtain his naturalization citizenship further. He immediately, after learning of his status, reported to Immigration in Orlando, and in my opinion, Paul Canton's nightmare began. Immigration has him as being immoral

because he illegally voted with his voter registration card that a clerk somewhere issued him. Immorality is grounds for deportation and denial of citizenship evidently.

Regardless, here we are in September 2023, and Paul Canton, former United States Marine, is still not a citizen. He has been in the immigration system since the incident with the driver's license back almost five years ago. His lovely wife has passed away since. She was deeply stressed by not knowing what tomorrow would bring. His children experience the trauma from all the hoopla and uncertainty. I thought the federal law Veterans Service Recognition Act 2022 would help him. Unfortunately, it does not consider the thousands of foreign-born non-citizen veterans from the past decades who need help. The 2022 Act applies only to current members of the Armed Forces and those within the grace period. Mr. Canton does not fall within the Veterans Service Act of 2022.

Where do we stand with Paul Canton? Rambana & Ricci, PLLC, Immigration Attorneys, have filed legal action on behalf of Paul Canton. Hopefully, once all parties are served process, the case can move forward, and the outcome will be in Mr. Canton's favor.

I was fortunate enough to be invited as the volunteer staff for the National 32nd American Legion Junior Shooting Sports Three-Position Air Rifle Competition held at the USA Olympic Training Center in Colorado

Springs July 20-22. There were 15 Precision Finalists and 14 Sporter Finalists competing in the event, along with chaperones and coaches. The competitors arrived on Tuesday and had orientation, equipment fitting, and training on Wednesday. That evening we were hosted by Legion Post 209 Colorado Springs for a hamburger/ hotdog barbecue and a DVD presentation on the Marksmanship Program. Thursday and Friday were two full days of competition for prone, kneeling, and standing positions. The final eight competitors for the shoot-off for each Precision and Sporter Category advanced to the final competition, held on Saturday morning, and is standing only with ten shots each announced by the visiting National Americanism. Sons of the Legion, and Auxiliary staff. That evening there was the Banquet and Award Ceremony with the presentation of the trophies, plaques, and medals to the various winners for each category and position. The Department of Florida was very fortunate to have the Sporter 2nd Place Award Runner-Up, Nathan Krokstrom, from the Mariner JROTC Marksmanship Team.

He received several medals and the 2nd place plaque. along with a \$1,000 Scholarship Award, which the Auxiliary sponsored. I was also fortunate to be invited by the Mariner JROTC Air Rifle Team SAL MAJ Williams, who held an Instructor Training 2 Day Clinic at the school cafeteria at the end of July for preparation for the upcoming year 2023-24. The Marksmanship Clinic included instructions on how to form a club, the rules of the competition, budget requirements, fundraising, and grants. Cadets were also available for demonstration as hands-on for the instructors with coaching for tournaments. It was a great turnout of instructors throughout the state as well as the local Lee County area. I want to thank Post 90, Cape Corral, and Chairman Dennis Stebbins, who, along with other post members, attended and assisted in sponsoring the event. It's easy to understand why Post 90 received the Department award for Best JROTC and Best JSSP Program Award. ABC News recently claimed that in July 2023, there was a 66% decrease in Police officers killed in the line of duty over that same period in 2022. However, the Officer Down Memorial page (Internet)

states that in July of 2023, 14 law enforcement officers across the nation were killed. This was the highest in many years. ABC claimed that the decrease was due to Covid. I don't know what that has to do

There will be more suggestions coming in the next edition of the Legion Link when Phase 2 of the plan goes into effect.

This year, in an effort to save money, the National office moved the National contest to Hillsdale College in Hillsdale, MI. It's a small college equidistant to Detroit, Toledo, Fort Wayne, and Grand Rapids. That changed the date for

#### **Resolution Direction**

While the Preamble section (the WHEREAS clause(s) that describe the problem) precedes the Resolving section (the RESOLVED clause(s) that detail suggestions on how the problem should be dealt with), the Resolving

section should be written first. Once the intent of the resolution is clearly stated, it is much easier to decide what statements need to be in the preamble to make clear the reasons for the resolution. During committee discussions or floor debates, the Resolving section is always amended first and the Preamble section last, as changes in the Resolving section may require changes in the Preamble section.

The Resolving section begins with the word "RESOLVED," usually printed in capital letters and followed by a comma. Between the opening word and the statement of the intent of the resolution, there should be the following information: the identification of the resolving authority, the circumstance and place of the action, and the date of

the action.

An example of a resolution initiated by a Post:

"RESOLVED, By Post No. \_\_\_\_\_, The American Legion,

Department of \_\_\_\_\_, in regular (or

special) meeting assembled in (place and date), That ..."

The word "That" (with a capital "T") is the first word that immediately follows the resolving clause and introduces the clause, which is the object of the verb "RESOLVED." It aids the reader in finding the point at which the meat of the resolution begins, and it aids the drafter of the resolution to launch a strong and unmistakable statement of intent.

Some examples:

RESOLVED, ...That The American Legion shall sponsor and support legislation to ..."  $\,$ 

RESOLVED, ...That The American Legion is opposed to repeal or weakening of..."

Although each resolution should deal with only one

subject, it is often necessary to attach additional clauses to a resolution's Resolving section to cover matters that are closely related to the main intent. This is especially useful for detailing how and by whom the intent of the resolution is to be accomplished.

#### Examples:

"RESOLVED, ... That ...; and, be it further
RESOLVED (as many as are required) That ...; and, be it
finally
RESOLVED, That ..."

Note that the identifying information is stated only once in the first RESOLVED clause and is not repeated in subsequent clauses. A period is used only once—at the close of the last clause in the Resolving section. Remember, the entire resolution is one continuous sentence.

The resolving section clause(s) should be able to stand on its/their own, even without the Preamble section, whereas clause(s) preceding it/them.

Greetings, fellow Legionnaires!
It seems like yesterday that we
were wrapping up our Department
Convention, and suddenly, it's
September. By the time you read
this, we'll have been to the National

Convention, and the American Legion will have a new National Commander.

I'd like to spend a minute addressing what seems to be some confusion regarding claims in connection with the PACT Act health-related claims. Yes, the deadline has passed by which claims that were filed, if granted, may have been backdated to August 2022. That does not

mean, however, that claims cannot be filed at any time. They certainly can. However, if granted, these claims will not be backdated past the date they were filed. Also, veterans who served in the war in Korea forward can still avail themselves of free screening for illnesses related to their service. Take advantage of this benefit at your local CBOC or VA hospital.

Also connected to healthcare, in early August, the VA literally rolled out an initial fleet of 25 mobile medical units throughout the country. These vans or trucks move from one location to another and provide private space for eligible veterans to meet with healthcare providers, including primary care, mental health clinicians, women's health, and more. The first of these mobile units here in Florida began their services at the Lake Nona VA hospital. Speaking of Lake Nona, I recently had the opportunity to participate in a preview of a new and highly advanced aid for veterans with profound hearing loss. This aid, called Xander Augmented Listening, is essentially a pair of glasses that "hears" what someone is saying and prints it out on the inside of one of the lenses of the glasses. This

will be next-level and enable hard-of-hearing veterans to be more comfortable carrying on conversations.

Continuing with healthcare, the VA has begun implementing the Dr. Kate Hendricks Thomas SERVICE Act. To sum up, this legislation expands breast cancer screening to toxic-exposed women veterans under age 40. It provides a risk assessment to determine if a mammogram is warranted, including toxic exposures, family history, and other factors. As with so many other diseases, early detection is key, so please spread the word about this.

In closing this month's article, I feel it necessary to revisit an issue I've spoken to before. There continue to

be groups and even individuals who present themselves as knights on white chargers, so to speak, offering to help veterans file claims and ultimately charge for their services. Some have gone so far as stopping just short of guaranteeing results. First, only some can guarantee results in connection to compensation claims. Second and most importantly, no veteran should have to pay for help filing a claim. The American Legion, as well as other recognized and reputable VSO, provide this service free of charge. Please be warned to avoid anyone who wants to charge a veteran or their family for this help, even if it's requested as a "donation." Should you or anyone you know be solicited for a pay-to-play fee in any form, please notify us so we can help.

This coalition has banded together as a united force to benefit the veterans and residents of our local communities. They collaborate to support one another in the advancement of each organization's goals. Out of this collaboration, the Challenge 22 event was conceived to address and help mitigate the following situation. In 2021, research found that 30,177 active-duty personnel and veterans who served in the military after 9/11 have died by suicide as compared to the 7,057 service members killed in combat in those same 20 years. That is, military suicide statistics are four times higher than deaths that occurred during military operations. The Challenge 22 event is now in its third consecutive year

and has achieved the followina:

- Advanced awareness in local communities throughout the district of the issue of veteran and military suicide,
- Provided a venue for regional activism in the successful mitigation of this issue,
- Illustrates the love and support of the American people towards our military active-duty and veteran personnel,
- Encouraged hope and support for the individual veteran and active-duty service member in their journey through the military service and after their return to civilian life.
- Increased awareness of our service members and veterans of the support organizations and benefits available to them, and finally,
- The Challenge 22 event proceeds made possible the following donations to Project Vet Relief and The Defenders of Freedom Florida Foundation:
  - » 2021 \$35,000 for Project Vet Relief,
  - » 2022 \$50,000 for Project Vet Relief and \$35,000 for The Defenders of Freedom Florida Foundation.
  - > 2023 pending

District One was a major contributor towards the Department Commanders' charity of choice, Project Vet Relief, in 2022 and received the Event of the Year Award from the Center for Strategic Military Excellence Alliance for 2022.
