experienced leaders. I knew what to expect, and I really believed that we, as a team, could make a difference. I believe any issues that arise could be handled swiftly and efficiently as we stay on course and continue moving forward. But there are times when issues come up that take you completely by surprise. These are issues that, number one, should never have happened and, number two, should have been squashed immediately at the Post level. How do we do this, you ask? By being involved! By knowing what's going on at your Post. Status Quo is wonderful when things are going great, but when drama occurs, most run for the hills. But how do we fix this, you ask? A few years ago, I wrote an article in the Legion Link called "Using your toolbox". Your toolbox is very simple and only contains two items. Constitution/Bylaws and Officers manual. 95% of all issues that arise within your Post can be rectified

by utilizing these two documents. Also, keep in mind that if you have questions and/or concerns, your District Commander is only a phone call away. But remember, the key is to be involved. Know what's happening at your Post, and if you have questions or concerns, attend the meetings and ask questions. People who don't follow the rules hate to be questioned.

I want to comment on a recent issue that came up in one of our Posts concerning the ADA and service animals. Resolution #357 was passed to make American Legion facilities accessible to and usable by disabled Veterans and their families. We will continue that long tradition of those who need it most. If an individual enters an American Legion Post with a service animal, the person cannot be asked about the nature or extent of the disability. Only two questions may be asked: 1. Is the animal required because of a disability? 2. What work or task has the animal been trained to perform? American Legion Posts should understand that service dogs are protected under the ADA and no Veteran should be denied access to a local Post, even if it has a "no pets" policy. The only exception is if the dog is not under the control of the Veteran and is a direct threat to others. It seems a bit hypocritical to Commander continued on page 2 >>

PTSD and Service Dogs Information

Comrades, We just completed our Fall Conference. I am so happy that many of you attended the needed training, and hopefully, you met with the Leading Candidate for the Next National Commander.

A question came up about Service Dogs in Posts. The Following is the answer provided by National, and it is in the Officer's Guide about service animals and posts. Let me know if you have any questions. Thanks!

"Post-traumatic stress is the "signature wound" of the conflicts in Iraq and Afghanistan, and VA estimates that up to 20 percent of U.S. Veterans suffer from it. As a result, there has been a dearth of new therapies and treatments to assist Veterans from all service eras in coping with PTSD.

In 2010, The American Legion created the TBI/ PTSD Committee to explore emerging treatments for mental health conditions and recommend those treatments to the Department of Veterans Affairs (VA) and the Department of Defense (DoD). Among them is the use of service dogs. Many Legionnaires have said that a trained service dog has had a positive effect on their lives, and emerging research backs up those claims; thus, in 2016, during the 98th National Convention in Cincinnati, The American Legion passed Resolution No. 134, "Service Dogs for Injured Service Personnel and Veterans with Mental Health Conditions." Veterans with PTSD use service animals to mitigate specific symptoms, such as recurring nightmares or anxiety attacks. The Americans with Disabilities Act (ADA), passed into law in 1990, is a federal prohibition on discrimination against disabled individuals. According to the ADA, this includes those who utilize service dogs for a disability.

Committees.

Most American Legion posts have been exemplary in their adherence to local, state, and federal disability laws, but a select few have not. Some local posts have failed to adequately recognize the value of service dogs for PTSD and have been in non-compliance regarding public access under the ADA. Care of disabled Veterans is one of the Legion's priorities, and through Resolution No. 7 – passed to make American Legion facilities accessible to and usable by disabled Veterans and their families – we continue that long tradition of supporting those who need it most.

The law requires the animal to be under the control of the handler at all times by harness, leash, or voice control. In complying with the ADA, American Legion posts should understand that service dogs are protected under the ADA and no Veteran with one should be denied access to a local post, even if it has a "no pets" policy. The only exception is if the dog is not under the control of the Veteran and is a direct threat to others.

If an individual enters an American Legion post with a service animal, the person cannot be asked about the American Legion."

the nature or extent of the disability. Only two questions may be asked:

- 1. Is the animal required because of a disability?
- 2. What work or task has the animal been trained to perform?

These questions should not be asked if the animal service's tasks are obvious, such as guiding an individual who is blind or has low vision, pulling a wheelchair, or providing stability. Furthermore, the ADA does not protect an "emotional support" or "comfort" animal, but state laws may differ. Post leadership should review all house rules and its constitution and by-laws to ensure compliance with federal, state, and local laws per service dogs, and Legionnaires should be briefed."

Sergeant-At-Arms Training

Continuing with the use of this platform to provide training to our Post and District Sergeant'sat-Arms. Setting up the meeting room is another essential role of the Sergeant-at-Arms. Below is a

diagram of the proper way to set up your meeting room. In my travels around the state, I see that many Posts follow this diagram, but there are still several Posts that do not. Remember, protocol is very important in our organization. penalties for violating the Code. Also, some folks think that if a U.S. Flag touches the ground, you must destroy it. Not True. As long as the flag is serviceable and suitable for display, the flag may continue to be displayed. Can a town Mayor or Post Commander order a U.S. Flag to be flown at half-staff? No, only the President of the United States or the Governor of a State can request a flag to be lowered to half-staff. Any others who order the flag to half-staff erode the honor and reverence of lowering the flag for the appropriate reasons. Did you know that the Flag Code does not have any provision against washing or dry-cleaning the

You Know, some people think that The American Legion wrote the Flag Code that was adopted by Congress. In fact, it was The American Legion and 68 other patriotic, fraternal, civic, and military organizations that met in Washington to draft the Flag Code that was adopted by the 77th Congress on June 22, 1942. Did you know that a flag used to drape a casket can be used for other purposes? It can even be used to display from a staff or flagpole. How about the Flag Code? It does not have any "On March 26, 2012, the House Committee on Veterans' Affairs Chairman Jeff Miller <u>unveiled the</u> <u>empty chair draped with the official POW/MIA</u> <u>flag</u> to honor America's Prisoners of War and those Missing in Action." "In 1970, Mrs. Michael Hoff, an MIA wife and member of the National League of POW/MIA Families, recognized the need for a symbol of our POW/MIAs. Prompted by an article in the Jacksonville, Florida, Times-Union, Mrs. Hoff contacted Norman Rivkees, Vice President of Annin & Company....He and an Annin advertising agency employee, Newt Heisley, designed a flag to represent our missing men." Since no trademark or copywriting was asked for, there is no restriction on its use.

The Pow/Mia Table:

The **table** is small, symbolizing the frailty of one prisoner, alone against his or her suppressors."

"The **tablecloth** is white, symbolic of the purity of their intentions to respond to their country's call to arms."

"The **single rose** in the vase signifies the blood they may have shed in sacrifice to ensure the freedom of our United States of America. The rose also reminds us of the family and friends of our missing comrades who keep faith while waiting for their return."

"The **red ribbon** on the vase represents an unyielding determination for a proper accounting of our comrades who are not among us."

"A **slice of lemon** on the plate reminds us of their bitter fate."

"The **salt** sprinkled on the plate reminds us of the countless fallen tears of families as they wait."

"The **glass** is inverted. They cannot toast with us at this time."

"The **candle** is reminiscent of the light of hope, which lives in our hearts to illuminate their way home, away from their captors, to the open arms of a grateful nation."

"The **American flag** reminds us that many of them may never return — and have paid the supreme sacrifice to ensure our freedom."

"The **chair** is empty – they are not here."

Inefficiencies in post operations, suspension, revocation, paying extra taxes, theft of post funds, loss of the Non-for-Profit status, or worse, a lawsuit that ruins the financial stability of their post and possible closure. The Visitation report has several areas: What programs and other things the post is engaging their community and Veterans. as well as member counts for their Legion Family groups, and is the post following the Officer's Guide for various leadership businesses or running their post-General Membership meeting IAW the manual. This one is one of our Department Commander's initiatives to have **"Back to the Basics training**," where it has been observed that some posts are not following either Department or National District 15 Commander continued on page 9 >>

recommendations. By doing it their way, it actually creates the situation where the post-meeting does not run smoothly, or worse, even becomes bizarre or out of control, causing it to run too long, making members leave, and, in some cases, never wanting to come to another meeting. Also, it looks at how the post engages their community at different levels and attributes.

But the most important items on the report are when the post filed their last 990, corporate report, sales tax certification, liability insurance, and how up-to-date their CBL (Constitution & By-Laws) is. Let's look at these:

990s; What or Why: If a post does not file

its 990 (no matter how large or small, including Homeless posts), it will lose its Non-for-profit status (though it could take a couple of years, it will happen). So which one should the post file? First of all, a post could file it on their own behalf, but when you have a complex financial post business, you should consider getting advice or employing an accountant (CPA). Therefore:

990s are filed when gross receipts are greater than \$200,000 or total assets are greater than \$500,000 at the end of the tax year.

990-EZ, known as the short form, is for

990-N (e-Postcard) is for organizations with gross receipts of less than \$50,000

Moving on, Sales Tax Certification, which allows the post to purchase items exempt from sales tax, renews in 5-year periods. Corporate Report (www.sunbiz.org): Your post is a not-for-profit corporation, and the Secretary of State requires all corporations to file an annual report by May 1st. I have observed the post's corporation being suspended, and it can cost the post a \$500 fine as well as reinstatement (which also has other fees). In fact, in District 15, there are six posts that, at some point, have been suspended (public records) for not filing their report. On that note, you should not file it too early; you say why. Well, on that report, you list the officers of the corporation, but you are having elections, and if you file early and new officers take office, you are required to send an amended report with the changes: yes, that's the law. This is also why you should have elections by April so you can file your report by May 1st. There is no reason to delay the election to the last minute; the new officers do not take office until they are officially installed. The Posts CBL is vital to "How the post is run and governed," to which the Department recommends reviewing them every three years and

programs. We hear from the Boys Nation President, the Eagle Scout of the Year, the JROTC Cadet of the Year, the Law Enforcement, Firefighter, and EMT of the Year, the Boys Baseball National Champion team, The National Oratorical Champion, Junior Shooting Sports Champions and so many more.

My first thought was, "How impressive are these

submitting them by the 4th year; some posts are ten or more years out of date, offering "we are going to work on that" but years go by. With that, if you are in leadership positions, "Do you have a current copy, and do you read it?" Lastly, let's look at **Insurance**: Having Insurance is critical, as well as coverage levels and who is covered. It would be best if you also had Fiduciary Liability, which covers theft within the post. Posts have seen \$25,000 or more stolen and were unrecoverable; with this insurance, the post would have recovered their loss, and the insurance company "Would seek the party to the fullest of the law." Safeguard your posts' assets and get the coverage.

I have done a complete review of my District, and all of my posts have not provided one or more of these (in paper form for records). Not that the post does not have or submitted them in a timely manner; they just have not given me a paper copy for the District records. These documentation verifications help make sure your post does not fall through the cracks or worse. The Department is only looking out for your post.

Cemetery Restoration

The Department of Veterans Affairs (VA) and National Cemetery Administration (NCA) are launching a nationwide initiative to acknowledge

and collaborate with community-led efforts to restore Veteran gravesites within historic private cemeteries.

Together, NCA and community members will share experiences and best practices for obtaining the necessary documentation for Veterans to receive burial benefits, how to safely clean Veteran headstones and markers, and other restorationrelated work.

This initiative complements community-led volunteer efforts nationwide that identify, restore, and preserve historic private cemeteries to respect and honor Veterans and others who may be buried there. <u>https://www.cem.va.gov/hmm/cemeteryrestoration.asp</u>

The U.S. Department of Veterans Affairs (VA) Veterans Cemetery Grants Program was established in 1978 to complement VA's national cemeteries. The program assists states, territories, and tribal governments in providing gravesites for Veterans in those areas where NCA cannot fully satisfy their burial needs.

VA has awarded grants totaling \$992 million

to establish, expand, improve, operate, and maintain 122 Veterans cemeteries in 49 states and territories, including tribal trust lands, Guam, Saipan, and Puerto Rico. In fiscal year 2022, NCA grant-funded state cemeteries provided more than 47,000 interments.

Grants may be used only to establish, expand, or improve Veterans cemeteries that are owned and operated by a state, territory, or tribal government on trust land. Aid is granted only to states, U.S. territories, and federally recognized tribal governments, not to private organizations, counties, cities, or other government agencies. <u>https://</u> www.cem.va.gov/grants/index.asp



Updates on Museum and DPAA Findings

On 4 November 2023, the Defense POW/MIA Accounting Agency (DPAA) held a virtual Family Member Update. Those of us who were able to view the live stream were updated on their most recent

efforts in specific conflicts, DNA advances, and DPAA lab findings. I must say it was very informative. The various presenters outlined how they will target an area for recovery efforts, the preparation of the site, and procedures for the proper excavation of the site. They then explained the lab work involved in the identification of those remains that were recovered. I encourage everyone to log onto the DPAA website <u>https://www.dpaa.mil/Livestreams/</u> and watch the Livestream to learn more. The next Family Update Meeting will be held on February 24, 2024, in Phoenix, AZ. Anyone who plans to attend normally starts at 11:00 AM; please check the DPAA website for possible changes/updates.

I do want to advise any POW/MIA Chair who reports to their post, District, or community on the status of POW/MIAs who have been recently identified by the DPAA to go to the "OUR MISSING" tab on the DPAA homepage. Open the tab and then click on "Recently Accounted For." Doing so will take you to the "Current Identifications by Conflict for FY 2024" page. Do not use the "NEWS & STORIES" tab, then the "News Releases" tab, as that will be the date of the Press Release for an individual repatriated. For instance, under News Releases, the top Press Release pertains to Airman D. Sexton, who was captured and died as a prisoner of war during WWII. His actual identification date was 13 July 2023, not 26 October 2023, which was the date of the Press Release announcing his identification. I know it may seem small and trivial; however, our job is to be as accurate as possible when making reports. The DPAA has identified 2 MIA DoD personnel for FY 2024. Their press release announcing their identification and circumstances surrounding their status will probably be made public in mid-2024.

I want to remind everyone that we have a solemn day approaching. It was on 3 February 1943; four Chaplains sacrificed their own lives to save others as the military transport ship USAT Dorchester was torpedoed by a German submarine. To my knowledge, their remains have never been recovered, making them MIAs who will likely never be recovered POW/MIA continued on page 16 >>

Legal issues: a resolution is a device by which a corporation formally grants authority to act in its name or to function. Hence, it needs to be absolutely clear and precise in the authority that is

granted.

A resolution should not use the words "partner" or "partnership." All those in a "partnership," whether individuals or entities, are liable for each other. The American Legion has no desire to become liable to anyone or any organization associated with a common interest or program. Use the word "relationship" instead.

The facts upon which a resolution is based should be

I also encourage you to visit the National POW-

for this program, so I hope that you, as your Post's Public Relations Chair, have received your packet as well. Please take the time to go through the material that was provided to you. There is a lot of helpful information included. Make sure that you gather all the information required throughout the year so that you are not scrambling at the last minute. The deadline for nominations is no later

very thoroughly researched and verified.

A resolution should NOT defame or cast aspersions. This can lead to significant liability for defamation of character, libel, and slander. It is always appropriate to add documentation. This is especially true if the facts or the issue might be unfamiliar to commission members, a resolution subcommittee of the NEC, or the members of the NEC. This becomes even more appropriate at a National Convention.

Should I write a resolution or not? Subjects for resolutions should be carefully considered. What are the facts? Are you just angry at a situation, and later, the "mountain" becomes a "molehill?" Or are others upset and wondering what to do to change the situation? Does the issue affect the whole community? Is the situation based on hearsay or fact? There doesn't have to be a controversy for MIA Memorial and Museum website, <u>https://</u> <u>powmiamemorial.org/</u>, to follow the progress being made to complete this wonderful and only National POW-MIA Memorial being built here in Florida. As of the end of August 2023, Phase 1 lighting work is almost complete. Overhead lighting has been installed along with lighting of the aircraft and pads. Lights have been added to the replica of the Cicel Field runway, and all looks great.

a resolution to be written. Before rushing to write a resolution, several fundamental questions should be asked about the subject matter. The importance of good writing technique and proper attention to grammar and spelling is essential.

The preamble to the constitution of The American Legion can be used as a guide as to the boundary within which subject matter should be kept. One should be wary of becoming a channel through which non-Legion organizations seek to achieve their own goals. Some things to consider:

- Ensure that the subject matter is relevant to the principles of our organization before submitting them.
- Does The American Legion already have a current position on the subject?

Critical Funding Needed

Our program has been grateful to be able to support Florida's veterans with financial aid for almost 10 years now. Our program is certainly proven to be viable and becoming a known resource to our veteran community. However, as the awareness and familiarity of our program grows, the importance for funding becomes even more critical!

In fact, PROJECT VetRelief's financial assistance applications keep multiplying and the amount needed has significantly increased. Not only are more people needing help, but the total dollar amount needed has also increased (i.e. increased cost of living, such as food, rent, and utilities or failed government assistance programs).

In the last two months, we saw record-breaking submitted applications and provided more financial support dollars. For reference, we typically have 30 approved cases and provide roughly \$30,000 in assistance per month. Our caseworkers received over 400 inquiries and issued more than \$46,000 in aid for September and October!

We are doing our best to meet this increased demand, but if we do not receive future funding, our program will be forced to make a difficult decision; how to prolong our funding and reduce the level of support provided.

Commission Submitted

WHEREAS, The American Legion affirmed its support for the principles and achievements of the Boy Scouts of America in the organization's first National Convention in Minneapolis, Minnesota, in 1919; and

WHEREAS, The Boy Scouts of America's focus on the development of youth as responsible citizens and future leaders of the United States align with the values and pillars of The American Legion and WHEREAS, The American Legion has encouraged Legionnaires to adopt Scout troops and assist in the mission of the Boys Scouts since 1920 at the community level; and

WHEREAS, The Boy Scouts of America has been an independent non-profit organization since 1910 with

its own governing rules not subject to the oversight or influence of other organizations; and

WHEREAS, The Boy Scouts of America has never been a youth program of The American Legion subject to national oversight, investigation or investment; and WHEREAS, In February 2019, the Boy Scouts of America rebranded their organization as Scouts BSA upon the inclusion of girls into the program; and WHEREAS, In 2020, Scouts BSA was subject to bankruptcy court following years of investigation and litigation involving allegations of the sexual abuse of minors; and

WHEREAS, In response to allegations of sexual abuse and subsequent litigation, Scouts BSA developed youth protection training as a requirement for those who participate in the development of Scouts and WHEREAS, Scouts BSA is making efforts to preserve the proud history and legacy of their organization for the benefit of our nation's youth;

now, therefore, be it

RESOLVED, By the National Executive Committee of The American Legion in regular meeting assembled in Indianapolis, Indiana, on May 10-11, 2023, that The American Legion reaffirm its longstanding support for the mission of Scouts BSA; and, be it further RESOLVED, That posts and Departments who sponsor or charter a Scout troop should comply with the training requirements of Scouts BSA; and, be it further

RESOLVED, That posts and Departments who sponsor or charter a Scout troop should require annual background checks be completed by Legionnaires and Legion Family members affiliated with Scouts BSA; and, be it further

RESOLVED That posts and Departments who sponsor or charter a Scout troop are encouraged to have legal liability insurance and, be it finally RESOLVED That resolution No. 103 "Boy Scouts of America" approved by the 1920 National Convention, resolution No. 390 "Boy Scouts" approved by the 1923 National Convention, and resolution No. 57 "Boy Scouts of America" approved at the 2012 Fall National Executive Committee meeting be rescinded by reason of being superseded.

Greetings once again, Legionnaires!

November was once again a busy month in many ways, not the least of which was that the Department conducted yet another Fall

Conference. Classes were conducted and attended, Department business was well conducted, and the camaraderie of enjoying our American Legion family brought us together again.

In the lead-up to the Conference, I had the honor of being asked to represent the Legion family at a 3-day panel at the Lake Nona VA hospital. Medical staff of all levels and design engineers from VA facilities throughout the country were brought together for a series of simulations to better the overall experience of healthcare delivery not only for Veterans but also for their families. It allowed me to see things from the "other side," so to speak, and I'm proud to have been part of this effort.

An issue that's been ongoing for quite a while is same-day outpatient surgical care for our fellow Veterans living in the northernmost part of the state. Essentially, this means those Veterans who live in

I'm happy to tell you that while no-cost healthcare and nursing home services were mandated by Congress over a year ago, they are finally being implemented. They will not face co-pays, registration fees, or monthly premiums. Let's reach out to that great generation of Veterans to ease any financial burdens we can handle.

In line with the idea of reaching out..while a week in October has been designated as a time for Buddy Checks, we can't stop there. Our connection to brother and sister Veterans lasts throughout the year. So, I encourage each of you to make a few phone calls to members of the Veteran community. They'll appreciate it, and you may very well be making a big difference in someone's life. This is a piece of information for those involved in lawsuits connected to the Camp LeJeune Justice Act. The Justice Department has ruled that attorneys representing Veterans cannot charge more than 25% of any judgments won. Until this decision, law firms charged as much as 65% of any money received. Finally, for now, for those Veterans who are thinking about filing claims for service-connected disability/ compensation, DO NOT PAY ANYONE TO FILE THESE CLAIMS! Only accredited VSOs can legally file claims, and the Veteran is never charged for that service. Any group or individual who offers "help" for a fee is doing so in violation of Federal Law.

So, this month's observation about life: Isn't it interesting that the idea of living a long life appeals to everyone, but the idea of getting old doesn't appeal to anyone?

was a proud Nationalist. Delegates already had to worry about whether they might win a preferred position, but there's a second dynamic of possibly winning the position for your party. As a cherry on top, your roommate will always be a member of the opposite party. So, you're basically "living with the enemy." There are all kinds of ways to represent yourself as a leader. District One's "Phoenix Post" with a passion for Veterans, Community, and the Arts

Pensacola, FL, is a city steeped in the history of the United States of America. The history of Pensacola, Florida, begins long before the Spanish claimed the founding of the modern city in 1698. The area around present-day Pensacola was inhabited by Native American peoples thousands of years before the historical era. Often referred to as "The City of Five Flags," Pensacola is known for having changed ownership several times. In 1821, under the Adams-Onís Treaty, Spain ceded all of Spanish Florida to the United States in exchange for payment. The American Legion was chartered by the United States Congress in 1919 as a patriotic Veteran's organization that focused on service to Veterans, service members, and communities and adherence to its Four Pillars:

- Veterans Affairs and Rehabilitation,
- Americanism,
- Children and Youth, and

rulings in high-level cases. The legislature holds its session, passing, negating, and debating bills created and drafted by fellow delegates. The governor merges everything together by implementing laws and managing the state with the help of his trusted cabinet. So... Frank R. Marston, Post 33, has been an American Legion Post from the beginnings of the American Legion and continues today. Its history is as varied as Pensacola's, and as such, the space allotted for this article prohibits further elaboration here. The current Commander of Post 33, Nicole Dickson, along with her tireless Historian, Dave Meron, maintains a detailed history of Post 33 and is proud to offer it to any Legionnaire who wishes to see it. One further historical incident remains to be illuminated. In 2019, The Department of Florida pulled the Charter of Post 33, and the Post was closed.



In August of 2020, Richard Hunter was joined by his daughter Carrie; they recruited a group of Veterans, including the current Commander, Historian, and Dan Woodcock, the current Building Manager and Sergeant-at-Arms. Richard then went to Sonny Decker (Western Area Commander) and Lamar Williams (District One Commander), and an

agreement was formed to resurrect Post 33 under the condition that it was to be run strictly as a post should be operated. The charter was re-established under the supervision of District One, and limited operations began; the charter was reinstated in July 2021. Post 33 leadership was contacted by the Community Redevelopment Agency in November 2022, and a grant for the restoration of the post exterior, \$140,000.00, was awarded in February 2023. Under the CRA grant, we restored the roof, repainted the exterior, fixed some exterior doors & windows, reconstructed both exterior awnings, installed all new exterior lighting, and Richard Barlow designed decorative railings in the 30's era style to further compliment the building.

Previous efforts to restore the beautiful wooden ceiling were completed after the roof restoration was accomplished. The latest addition to the interior was a patriotic-themed mural on the north wall. Dickson credits the members of the Pensacola Mural Fest 2023 (artist-in-residence Monty Welt) for the beautiful mural that was painted this year.

The vision of what Post 33 members want to see inside the post walls is endless because they have the space. Besides the stage, there's a kitchen with an original stone fireplace, a ballroom, and several large meeting rooms upstairs and in the basement. "The potential for the building is enormous," Dickson said. It can even be rented out for events, which is how David Henderson and his wife joined. They were looking to rent the hall, and after speaking with Dickson, they joined Post 33 "and jumped in with both feet." "I'm excited to be a part of something that is moving forward," said Henderson, Post 33's past Judge Advocate and Public Affairs officer. Henderson is looking into establishing programs at the post, such as helping feed homeless Veterans, hosting craft fairs, and re-establishing the school program where kids come to the Post to do their homework with the help of Veterans. "In rebuilding the history of Post 33, we want to rebuild the school program part and let people know that we are here and that we can help," he said. "We are focusing on the four pillars of The American Legion and trying to get back to being an American Legion post and service to the community through that first and then as a venue second. "I want to see the American Legion post be that service back to the community. To bring back that reminder that Veterans are still helping in the community long after our service ended, we still serve where our hearts have been. I would like Post 33 to become that shining example of a place where service happens." Overall, creating

a supportive, safe place for Veterans, youth, and the community is a passion for the Veterans of Post 33. "My husband is a 20-year retired Veteran," said Dickson, an Army Veteran. "We have seen the difficulty that Veterans can have firsthand. For example, navigating the VA or knowing where to go to get VA benefits to have a point of contact for something they might need. Many of us at (Post) 33 feel very strongly about (Post) 33 becoming a place where Veterans can go; younger Veterans sometimes don't feel they have a place to go, and Post 33 wants to be that place. It's really hard when you get out to find the people to build a community with, and Post 33 wants to be there for those Veterans who are just getting out, who don't really have a community of their own, and we want to be able to support them.

"That's really why we all stuck around ... we are that younger generation. When we found each other, we found a little family, and we just got together and was like, 'OK, we're going to do this together.'" The post currently has around 50 members and is actively getting a Sons of The American Legion squadron and Auxiliary unit underway. Rick Cusimano (a past Post 33 Commander) believes once the exterior of Post 33 is complete, it will drive people to join. "As soon as the outside of the building starts looking nice again, that's where the draw will come in," he said. "It's going to start attracting more members, but it's also going to start attracting the community we belong to, and that's where we're going to start accelerating in the things we want to aet done."

What drives Cusimano to continue the path forward with Post 33 is "the memories the building has with people" and the possibility of helping the community again through financial assistance. A visitor stopped by the post and reminisced with Cusimano when their grandparents did ballroom dancing there 40

years ago. Then, a JROTC student helping paint at the post shared that his grandmother told him Post 33 helped her family financially in a time of great need. "I thought that's the things I want to become a part of again ... we can help Veterans, we can help the community, we can be a place for kids to come and be safe," he said. "The biggest thing is just to be a part of everything. Those are the stories that I love hearing, which drives me to continue with what we're doing."

If you speak with those helping re-energize life back into Post 33, you will hear in their voices passion for the post home and a strong drive to be part of the Pensacola community again. This makes it understandable why the community is rallying around them. "Our enthusiasm is kind of infectious," Dickson said. "If you care about that building at all, you're going to join."
