# National Commander or National guests visit preparation:

1. Meeting Setting: Meetings should be held in a more formal meeting space.

However, if in a lounge is the only available space, efforts should be made to minimize the appearance of a "bar" and smoking should be prohibited during the meeting.

- Engagement with Members: At meetings, National Commanders and Vice Commanders should be able to address members and discuss plans for the year. Members should be encouraged to ask questions and engage with the national guests respectfully.
- Gifts and Donations: While presentations and gifts can be given to visiting guests, a donation to their chosen charity is often appreciated the most. Arrange for a photo backdrop that does not include a bar-style setting.
- 4. **Communication:** National leaders are interested in the Post's membership status, programs, community interactions, and relationships with local leaders.

# National Commander or National guests expectations:

The National Commander or National Vice Commander typically wants to gather information and insights on several key areas during their visit to a Post:

- Membership and Post Programs: They are interested in learning about the current status of membership within the Post, including any challenges or successes in recruitment and retention efforts. Additionally, they want to know about the various programs and activities the Post is involved in, such as community service projects, veteran support initiatives, and youth programs.
- 2. Post's Performance and Interactions with the Community: They want to understand what initiatives and strategies are working well for the Post, as well as any areas where improvement may be needed. This includes assessing the Post's effectiveness in engaging with the local community, supporting veterans, and promoting the organization's mission and values.
- 3. Relationships with Community Leaders: They are interested in the Post's relationships with key community stakeholders, such as City Council Members, Mayors, Senators, Representatives, and Congress Members. They want to know about any collaborations, partnerships, or advocacy efforts the Post is involved in, as well as opportunities for further engagement and support from these leaders.

Overall, the National Commander or National Vice Commander wants to see a thriving and active Post that is making a positive impact in its community, effectively supporting its members, and upholding the values of the organization. They value open communication, collaboration, and a commitment to the organization's mission and objectives.

### **Department Level:**

- 1. Issue Resolution: Post-related issues should be addressed internally at the Post and, as a last resort, at the Department level rather than escalated to National Headquarters.
- Understanding Policies: Members are encouraged to familiarize themselves with the Post's Constitution and ByLaws for clarity on procedures and regulations.
- 3. Educational Resources: The 2024 Office's Guide and Manual of Ceremonies and the Department of Florida Constitution and Bylaws are recommended resources for further understanding and guidance.

Overall, these guidelines emphasize effective communication, respect for protocols, and a focus on community engagement and support. They aim to ensure smooth operations and cohesion within the organization at various levels.

I would like to thank everyone who attended the Washington Conference and visited with Florida's House Representatives and Senators. We

had a good turnout this year, and while the House was not in session, we did make our presence known. Thank you. Some of the items we discussed with our House and Senate officials included:

- Major Richard Star Act, in which Service Members who were medically retired have full access to both Military Retirement Pay and Disability Benefits
- Update base housing and barracks. The military is still using temporary housing built in WWII as barracks and housing.
- Post's Florida Corporation Annual Report due May 1, 2024

May 1, 2024, is rapidly approaching. The Post's Florida Corporation Annual Report should be submitted to <u>https://dos.</u> <u>fl.gov/sunbiz/</u> by 11:59 pm Eastern time on Wednesday, May

1, 2024 (Non-Profit Corporations are not subject to the \$400 late fee). If the Annual Report is not filed by the third Friday in September, an administrative dissolution of the Post's Corporation will be processed by the State of Florida. The dissolution of the Post's Corporation means the Post is no longer Incorporated, and the Post's Consumer's Certificate of Exception status is revoked. When the Certificate is revoked, the Post is no longer considered a tax-exempt entity.

As you file your Annual Report, you may notice a new Federal requirement effective January 1, 2024, for Reporting Beneficial Ownership Information. I researched this requirement at <u>https://www. fincen.gov/boi-faqs</u>. Tax-exempt corporations are exempt from this filing requirement per Frequently Asked Questions C.2 line 19 in the Table of Exempt Companies.  Pay the Coast Guard; we just missed the bullet again this year.

- Cap lawyers pay to process claims for our Veterans, such as those stationed at Camp Lejeune.
- 5. Suicide Prevention

**Reminder:** July 1st will bring an increase in dues. However, you can now renew online at the current rate up to 2027. Go to www.legion.org, click on the Renew tab, and fill out the information.

Note: Per the 2023-2024 Florida Department Training Guide, each Post in Florida is required to be incorporated under the laws of the State of Florida (Department Constitution, Article X, Section 18). This is required not only to protect the Post but also to protect its membership. If a Post is not incorporated and a lawsuit is brought against it, the Post, its officers, and its members may be held financially liable).

The same website, <u>https://dos.fl.gov.sunbiz</u>, provides information on how to incorporate, reinstate, or validate a corporation's status.

do, and decide to join. But how many times do we join a Post and immediately our number of friends grows!

So now, when I'm asked what the American Legion is, I tell them I could give them a long explanation,

but to me, it's just three simple words: *Veterans, Family, and Friends*!

So, how is membership doing in the Central Area? Membership within the Central Area and Department is moving at a great pace. The 7th District is currently at 95.91%. They have 9 of their 12 Posts over 90%, with 5 Posts over 100%. The 15th District is at 94.43%, with 15 of their 17 Post over 85%, with 5 Post over 100%. The 16th District is currently at 91.76 1%, which, due to its size, is the largest District in the Department. It always starts slow but is gaining momentum. The 16th District has 12 of its 15 Posts over 85%, with 1 Post at 100%.

Many of our Posts offer scholarships to graduating high school seniors or provide financial assistance for educational programs. 4100 members more than last year. The National Report on March 11, 2024, had us in 5th place at 93.27%, and our renewal rate was 89.16%. The three-year renewal option is available to every member now, and everyone should take advantage of it. With National going up 5.00 per capita on July 1, it is a great way for your members and your Post to save some money. National will be absorbing the cost of the increase for those members who do the three-year renewal!

# POW/MIA Memorial & Museum Update and Update on MIA's recovered

Phase 1 of the National POW/MIA Memorial & Museum <u>https://</u> <u>powmiamemorial.org/</u> is progressing nicely. Burlington Concrete Construction is providing cul-de-sac construction and flagpole

island construction. The Holman Inc. completed the flagpole raising and setting with Federal Flags of Georgia providing the 50' pole and flag, which looks terrific. Phase 1 lighting project is almost completed, along with the lighting of the aircraft. Runway lights have been added to the replica of the Cecil Field runway, and they look great.



Congressman Aaron Bean introduced the National POW/MIA Memorial and Museum Act H.R. 3670 in May 2023. This bipartisan Bill will designate the POW/MIA Memorial and Museum at Cecil Field to serve as a national landmark to honor, connect, inspire, and educate the American people about members of the Armed Forces who were held as prisoners of war (POWs) and those who became missing in action (MIA) in our nation's conflicts. Please go to <u>https://powmiamemorial.org/</u>, scroll down the page until you see the "Help Us with Our National Designation" tab, and click the Sign Our Petition.

### Defense POW/MIA Accounting Agency News

Did you know that more than 120,000 American military personnel served in China during WW II

when the two sides fought against Japan? It is believed there are about 690 unaccounted-for Americans within modern-day mainland China. During a meeting in Hawaii in August, DPAA director Kelly McKeague reportedly asked South Korean vicedefense minister Shin Beom-Chul for help to contact the Chinese side in trying to restart the recovery mission, according to South Korea's Yonhap News Agency.

Seoul has worked closely with Beijing on recovering the remains of soldiers killed during the 1950-1953 Korean War, and it has returned the remains of 938 Chinese troops since 2014. Because of this cooperation, Korea was instrumental in encouraging the Chinese to hold a video meeting with the US about cooperating to find the remains of American POW/MIA, or prisoners of war/missing-in-action). The US military has completed two site surveys to recover WW II remains in China. Recently, a team with the US Defense POW/MIA Accounting Agency (DPAA) "spent several weeks surveying sites in southern China in order to provide vital information for future recovery missions".

The Defense POW/MIA Accounting Agency (DPAA) <u>https://www.dpaa.mil/</u> has currently identified for FY 2024 27 personnel from WW II, four from the Korean War, and one from the Vietnam War.

# Youth Law Cadet Program Update

Our last correspondence with the Florida Highway Patrol was on February 15th. We sent the lieutenant the same letter we sent to the Department Area/ District Commanders and program

Chairs for this program. His response was that he was still waiting to hear from his legal department regarding our application paperwork. We're hoping the Florida Highway Patrol will succeed and have an outstanding program for us.

The total cost per **cadet is \$500.00** (this is NON-REFUNDABLE). This includes: lodging, meals, two neon orange performance polo shirts, three dri-fit sport-tek t-shirts, one port authority cotton cinch pack, one tan hat, one water bottle & one patch. Cost per **chaperon: \$400.00** (also NON-REFUNDABLE). This includes: lodging and meals. The cadets are responsible for the following:

- Three pairs of black BDU's pants
- Two pairs of black athletic shorts
- One pair of black athletic shoes
- One pair of black dress shoes/boots
- Personal toiletry items
- Care of clothing

Transportation to/from the academy is the responsibility of the District, Post, and parents. cadets cannot drive or park a personal vehicle on academy grounds.

Please keep in mind the cost for this program is the responsibility of the District or the Post or the cadet/ student, not the Department.

Please keep in mind that if we are able to send 32 cadets , the Florida Highway Patrol wants us to have eight chaperones. I am sure we will have females

attending, so we will need female chaperones. Please keep in mind that this obligation will be for one week. We have yet to receive a confirmed date for the start of the academy from Florida Highway Patrol. YES, I still have hope.

In April, I am going to ask the Lieutenant for an appointment to meet with him and hopefully, his supervisors will nail down the program and a date for the start of the program.

Registration and checking-in and out information will be supplied as soon as Florida Highway Patrol verifies the date and times for the program.

Your Legislative Commission participated in the **March on the State Capital** for Veterans Legislation in Tallahassee on February 21st. The Department of Florida Legislative Chairman Stuart Scott coordinated with our Florida American Legion Family to meet with legislators.

We attended the House Judicial Committee who were debating House Bill 189 to amend the state gaming laws. These laws could affect the way our TAL FL Posts operate our bingo pull tab machines.

A strong turnout by The American Legion received recognition from the House Judiciary Committee Chairman and various other members of the committee resulting in amending the bill that is more suitable to our Post operations. This is why we encourage all members of the Florida American Legion Family to get in touch with your state representative and senator and simply let them know you are a member of the Florida American The American Legion Legacy Scholarship.

The American Legion's Legacy Scholarship provides college funding to children of Post-9/11 Veterans who died on active duty or those who have a combined VA disability rating of 50 percent or greater. Applications will be considered from January 1 to Wednesday, March 27, 2024.

As a volunteer organization, we are all familiar with the struggles of recruiting and retaining leaders. The trick to getting your members to serve at the Post is to break it down by tasks. Don't ask someone if they want to be an officer or even serve on a committee; ask them if they could spare an hour or two once a month to (fill in the blank).

By eliminating the position in your pitch, you remove the barriers and reservations in a person's mind to serving in a responsible capacity. Once the unknown becomes known, the fear is gone in the volunteer's mind and is replaced by comfort and routine.

As Veterans, we are all responsible and have demonstrated this in our military service. The desire to volunteer is a deep well in the heart of vets; with the right communication, you can draw it out.


